A BILL**TO AMEND ARTICLE III OF THE STUDENT GOVERNMENT BYLAWS**

- PARAGRAPH 1:** WHEREAS, THE STUDENT GOVERNMENT BYLAWS DO NOT MANDATE THAT SENATORS PARTICIPATE IN STUDENT OUTREACH EVENTS; AND
- PARAGRAPH 2:** WHEREAS, THE BYLAWS NEED TO BE REVISED TO STATE THAT EACH SENATOR MUST ATTEND A MINIMUM OF TWO (2) STUDENT OUTREACH EVENTS; AND
- PARAGRAPH 3:** WHEREAS, EACH SENATOR MUST ATTEND AND PARTICIPATE IN ONE (1) STUDENT OUTREACH EVENT BY THE NINTH (9TH) LEGISLATIVE WEEK; AND
- PARAGRAPH 4:** WHEREAS, STUDENT OUTREACH EVENTS SHALL INCLUDE BUT NOT BE LIMITED TO ORGANIZATION VISITS, CHATS WITH THE CHANCELLOR, AND STRAIGHT TALKS; AND
- PARAGRAPH 5:** WHEREAS, IF A SENATOR DOES NOT ATTEND AT LEAST TWO (2) STUDENT OUTREACH EVENTS, WITH ONE (1) BEING BEFORE THE NINTH (9TH) LEGISLATIVE WEEK , HE OR SHE WILL VACATE HIS/HER SEAT IMMEDIATELY
- PARAGRAPH 6:** WHEREAS, EVENTS OTHER THAN SPECIFICALLY-STATED STUDENT OUTREACH EVENTS MUST BE APPROVED UNANIMOUSLY BY THE CHAIR AND VICE CHAIR OF THE STUDENT OUTREACH COMMITTEE AND MUST BE PRESENTED NO LATER THAN TWO (2) DAYS BEFORE THE EVENT TAKES PLACE; AND
- PARAGRAPH 7:** WHEREAS, ARTICLE III SECTION 1:C AND SECTION 4:F OF THE STUDENT GOVERNMENT BYLAWS SHOULD READ AS FOLLOWS:

ARTICLE III**LEGISLATIVE BRANCH AFFAIRS****SECTION 1. STUDENT SENATOR DUTIES**

- C. EACH SENATOR MUST ATTEND AND PARTICIPATE IN A MINIMUM OF TWO (2) STUDENT OUTREACH EVENTS PER SEMESTER INCLUDING BUT NOT LIMITED TO ORGANIZATION VISITS, CHATS WITH THE CHANCELLOR, AND STRAIGHT TALKS.
1. EACH SENATOR MUST ATTEND AND PARTICIPATE IN ONE (1) OF THE STUDENT OUTREACH EVENTS BY THE NINTH (9TH) LEGISLATIVE WEEK.

- A. IF APPOINTED AFTER THE FOURTH (4TH) LEGISLATIVE WEEK, THE SENATOR MUST PARTICIPATE IN ONE (1) EVENT.
 - B. IF APPOINTED AFTER THE NINTH (9TH) LEGISLATIVE WEEK, THE SENATOR IS NOT REQUIRED TO PARTICIPATE IN ANY EVENTS.
2. THE PROPOSED EVENT MUST BE PRESENTED TO THE CHAIR OF THE STUDENT OUTREACH COMMITTEE NO LATER THAN TWO (2) DAYS BEFORE EVENT TAKES PLACE.
 3. EVENTS OTHER THAN SPECIFICALLY-STATED STUDENT OUTREACH EVENTS MUST BE APPROVED UNANIMOUSLY BY THE CHAIR AND VICE CHAIR OF THE STUDENT OUTREACH COMMITTEE

SECTION 4. REMOVAL OF SENATORS

- F. IF A SENATOR FAILS TO ATTEND AND PARTICIPATE IN A MINIMUM OF TWO (2) STUDENT OUTREACH EVENTS PER SEMESTER, THE SENATOR SHALL BE REMOVED FROM HIS/HER POSITION ON SENATE UNLESS EXCUSED UNANIMOUSLY BY THE SPEAKER OF THE SENATE AND THE SPEAKER PRO TEMPORE.

PARAGRAPH 8: THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THUS AMENDS ARTICLE III OF THE STUDENT GOVERNMENT BYLAWS

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
