8 **TO AMEND ARTICLE III, SECTION 7, SUBSECTIONS B AND C OF THE LSU STUDENT**  
9 **GOVERNMENT BYLAWS**

10 **PARAGRAPH 1:** WHEREAS, CURRENTLY THERE ARE ONLY SET ITEMS ABLE TO BE  
11 DISCUSSED AT BOTH THE FALL AND SPRING ORGANIZATIONAL  
12 SESSIONS OF THE STUDENT SENATE; AND

13 **PARAGRAPH 2:** WHEREAS, IF ANY LEGISLATION NEEDS TO BE SUBMITTED FOR  
14 DISCUSSION AND APPROVAL THAT DOES NOT FALL INTO THIS  
15 CATEGORY, IT WOULD NOT BE ALLOWED TO BE HEARD IF A  
16 STRICT CONSTRUCTION OF THE RULES WERE TO BE APPLIED; AND

17 **PARAGRAPH 3:** WHEREAS, ANY LEGISLATION THAT DOES NOT MEET THE  
18 CURRENT SET CRITERIA WOULD HAVE TO BE VOTED ON IN A  
19 SPECIAL SESSION OF THE STUDENT SENATE; AND

20 **PARAGRAPH 4:** WHEREAS, ATTENDANCE AT SPECIAL SESSIONS OF THE  
21 STUDENT SENATE HAVE BEEN HISTORICALLY LOW; AND

22 **PARAGRAPH 5:** WHEREAS, ARTICLE III, SECTION 7, SUBSECTION B WOULD  
23 NOW ADD:

24 7. ANY OTHER LEGISLATION SUBMITTED THAT IS DEEMED  
25 IMPORTANT AND URGENT BY THE SPEAKER OF THE  
26 SENATE, OR BY SUBSEQUENT APPEAL OF THE DECISION OF

29 **PARAGRAPH 6:** WHEREAS, ARTICLE III, SECTION 7, SUBSECTION C WOULD  
30 NOW ADD:

31 14. ANY OTHER LEGISLATION SUBMITTED THAT IS DEEMED  
32 IMPORTANT AND URGENT BY THE SPEAKER OF THE  
33 SENATE, OR BY SUBSEQUENT APPEAL OF THE DECISION OF  
34 THE CHAIR BY A (1/2) MAJORITY VOTE OF THE MEMBERS OF  
35 THE SENATE

36 **PARAGRAPH 7:** THEREFORE, BE IT ENACTED BY THE STUDENT  
37 GOVERNMENT OF LOUISIANA STATE UNIVERSITY  
38 AGRICULTURAL AND MECHANICAL COLLEGE THAT  
39 ARTICLE III, SECTION 7, SUBSECTIONS B AND C OF THE STUDENT  
40 GOVERNMENT BYLAWS BE AMENDED

41 **PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS  
42 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
