**A BILL****TO AMEND RULE 6.3 OF THE STUDENT SENATE RULES OF ORDER**

**PARAGRAPH 1:** WHEREAS, CURRENTLY IN ROBERT'S RULES OF ORDER IT LIST THAT EX-OFFICIO MEMBERS RESERVE THE RIGHT TO VOTE ON MATTER PERTAINING TO THE COMMITTEE IN WHICH THEY ARE ASSIGNED; AND

**PARAGRAPH 2:** WHEREAS, THE CURRENT RULE 6.3 OF THE STUDENT SENATE RULES OF ORDER READS:

**Rule 6.3 Ex-officio Committee Members**

Ex-officio members of the Student Senate standing committees shall include:

- A. The President of the Honors College Student Council or his-her designee, the Director of Athletics or an equivalent position or his or her designee, the Director of Policy Development or an equivalent position or his or her designee, and the Director of Academics or an equivalent position or his or her designee shall be an ex-officio member of the Committee on Academics, Athletics, and Administration.
- B. The chief financial officer will be an ex-officio member of the Committee on Finance.
- C. The Director of Governmental Relations or equivalent position or his or her designee shall be an ex-officio member of the Committee on Governmental Relations.
- D. The President of the Residence Halls Association, or his/her designee and the Director of Technology or an equivalent position or his or her designee, shall be an ex-officio member of the Committee on Housing, Infrastructure, and Technology.
- E. The Speaker of the Student Senate shall serve as an ex-officio member of the Committee on Rules.
- F. The Safety Coordinator will be an ex-officio member of the Committee on Students' Rights and Welfare.

**PARAGRAPH 3:** WHEREAS, THE NEW AND AMENDED RULE 6.3 SHALL READ:

**Rule 6.3 Ex-officio Committee Members**

Ex-officio members of the Student Senate standing committees shall include:

- A. The President of the Honors College Student Council or his-her designee and the Director of Academics or an equivalent position or his or her designee shall be an ex-officio, **non-voting** member of the Committee on Academics
- B. **The Director of Athletics or an equivalent position or his or her designee shall be an ex-officio, non-voting member of the Committee on Athletics**
- C. The President of the Residence Halls Association, or his/her designee, **the Executive Director of the Greek Board of Directors or his or her designee, the Director of Transportation or an equivalent position or his or her designee, the Director of Campus Development or an equivalent position or his or her designee, the Director of Sustainability or an equivalent position or his or her designee,** the Director of Technology or an equivalent position or his or her designee, shall be an ex-officio, **non-voting** member of the Committee on **Campus Services and Development.**
- D. The Director of **External Affairs** or an equivalent position or his or her designee shall be an ex-officio, **non-voting** member of the Committee on **External Affairs.**
- E. The chief financial officer **or an equivalent position or his or her designee shall** be an ex-officio, **non-voting** member of the Committee on Finance.
- F. The Speaker of the Student Senate shall serve as an ex-officio, **non-voting** member of the Committee on Rules.
- G. **The Director of Organization Outreach or an equivalent position or his or her designee, the Director of Student Involvement or an equivalent position or his or her designee,** and the Safety Coordinator will be an ex-officio, **non-voting** member of the Committee on **Student Outreach**

; AND

**PARAGRAPH 4:** THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE AMENDS RULE 6.3 OF THE STUDENT SENATE RULES OF ORDER.

**PARAGRAPH 5:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
