9 **TO AMEND THE LOUISIANA STATE UNIVERSITY STUDENT GOVERNMENT RULES OF**
10 **ORDER TO RESTRUCTURE THE STANDING COMMITTEES OF THE SENATE**

11 **PARAGRAPH 1:** WHEREAS, RULE 6.1 OF THE LSU STUDENT GOVERNMENT
12 RULES OF ORDER SHOULD BE AMENDED TO READ:

14 A. THERE SHALL BE SEVEN (7) STANDING COMMITTEES OF
15 THE STUDENT SENATE WHOSE DUTIES RESPECTIVELY
16 SHALL BE TO TAKE INTO CONSIDERATION ALL SUCH
17 SUBJECTS AS PROPERLY PERTAIN TO THE SUBJECTS AND
18 PURPOSES ASSIGNED TO THEM AND WHICH MAY BE
19 REFERRED TO THEM BY THE SENATE.

21 B. THE SEVEN (7) STANDING COMMITTEES OF THE SENATE
22 SHALL BE THE FOLLOWING:

- 23 1. ACADEMICS
- 24 2. ATHLETICS
- 25 3. CAMPUS SERVICES AND DEVELOPMENT
- 26 4. EXTERNAL AFFAIRS
- 27 5. FINANCE
- 28 6. RULES
- 29 7. STUDENT OUTREACH

31 **PARAGRAPH 2:** WHEREAS, RULE 6.3 SHOULD BE AMENDED TO READ:

33 ALL SENATE STANDING COMMITTEE CHAIRS AND MEMBERS OF
34 THE EXECUTIVE BRANCH SHALL BE RESPONSIBLE FOR WORKING
35 IN COOPERATION WITH THEIR RESPECTIVE COUNTERPART.

- F. THE SPEAKER OF THE STUDENT SENATE SHALL SERVE AS AN EX-OFFICIO MEMBER OF THE COMMITTEE ON RULES.
- G. THE DIRECTOR OF STUDENT INVOLVEMENT OR HIS OR HER DESIGNEE, THE DIRECTOR OF ORGANIZATIONAL OUTREACH OR HIS OR HER DESIGNEE, AND THE DIRECTOR OF FIRST YEAR EXPERIENCE OR HIS OR HER DESIGNEE WILL BE EX-OFFICIO MEMBERS OF THE COMMITTEE ON STUDENT OUTREACH.

PARAGRAPH 3: WHEREAS, RULE 6.4 SHOULD BE AMENDED TO READ:

ALL LEGISLATION, EXCEPT BILLS OF IMPEACHMENT, SHALL BE REFERRED BY THE SPEAKER ACCORDING TO THE TOPIC MATTER AS HEREINAFTER SET FORTH TO ONE (1) APPROPRIATE STANDING COMMITTEE LISTED HEREIN; PROVIDED, HOWEVER THAT AT THE TIME OF REFERRAL ANY MEMBER MAY OBJECT TO THE REFERRAL AND MAY MOVE TO ASSIGN THE LEGISLATION TO ANOTHER COMMITTEE NAMED IN THE MOTION.

A. **ACADEMICS:** TO THIS COMMITTEE SHALL BE REFERRED, IN ACCORDANCE WITH THE RULES, ALL LEGISLATION AND OTHER MATTERS RELATING TO THE FOLLOWING SUBJECTS:

- 1. ACADEMIC, EDUCATIONAL AFFAIRS AND PROGRAMS.
- 2. UNIVERSITY FACULTY
- 3. LSU STUDENT GOVERNMENT TEXTBOOK EXCHANGE.
- 4. COMPUTER-BASED TESTING
- 5. FINANCIAL AID
- 6. CODE OF STUDENT CONDUCT
- 7. ALL OTHER MATTERS AS ORDERED BY THE STUDENT SENATE.

B. **ATHLETICS:** TO THIS COMMITTEE SHALL BE REFERRED ALL LEGISLATION AND OTHER MATTERS RELATING TO THE FOLLOWING SUBJECTS:

- 1. UNIVERSITY-AFFILIATED ATHLETICS AND INTRAMURAL SPORTS GENERALLY.
- 2. MATTERS RELATING TO PRIORITY POINTS AND STUDENT TICKETS.
- 3. ALL OTHER MATTERS AS ORDERED BY THE STUDENT SENATE.

C. **CAMPUS DEVELOPMENT AND SERVICES:** TO THIS COMMITTEE SHALL BE REFERRED ALL LEGISLATION AND OTHER MATTERS RELATING TO THE FOLLOWING SUBJECTS:

4. OTHER UNIVERSITY GOVERNING BODIES SUCH AS FACULTY AND STAFF SENATES.
5. VOLUNTEER AND COMMUNITY SERVICES.
6. OTHER MATTERS AS ORDERED BY THE STUDENT SENATE.

F. RULES: TO THIS COMMITTEE SHALL BE REFERRED ALL LEGISLATION AND OTHER MATTERS RELATING TO THE FOLLOWING SUBJECTS:

1. SERVICES OF OR FOR THE STUDENT SENATE, ITS MEMBERS AND/OR ITS COMMITTEES.
2. ALL CONSTITUTION AND/OR BYLAW AMENDMENTS.
3. LEGISLATIVE RULES AND PROCEDURES.
4. ELECTIONS AND ELECTION BOARD.
5. APPOINTMENT OF PERSONS TO OFFICE IN THE STUDENT GOVERNMENT.
6. OTHER MATTERS AS ORDERED BY THE STUDENT SENATE.

G. STUDENT OUTREACH: TO THIS COMMITTEE SHALL BE REFERRED ALL LEGISLATION AND OTHER MATTERS RELATING TO THE FOLLOWING SUBJECTS:

1. ALL MATTERS RELATED TO, INCLUDING FACILITATION OF, THE "ORGS2GEAUX" PROGRAM.
2. STUDENT-RELATED AUXILIARIES.
3. UNIVERSITY DISCIPLINARY REGULATIONS.
4. CULTURAL AFFAIRS AND PROGRAMS.
5. ALL MATTERS PERTAINING TO STUDENTS' CONSTITUTIONAL RIGHTS AND CIVIL LIBERTIES.
6. SCHOOL AND COLLEGE COUNCIL AFFAIRS GENERALLY.
7. STUDENT GROUPS AND ORGANIZATIONS.
8. ENTERTAINMENT EVENTS AND ORGANIZATIONS.
9. ALL MATTERS PERTAINING TO FREE SPEECH ALLEY.
10. ALL MATTERS PERTAINING TO FIRST YEAR EXPERIENCE
11. ALL MATTERS PERTAINING TO THE SATISFACTION OF THE DUTIES OF SENATORS.
12. OTHER MATTERS AS ORDERED BY THE STUDENT SENATE.

PARAGRAPH 4: THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT THE LSU STUDENT GOVERNMENT SENATE RULES OF ORDER BE AMENDED TO RESTRUCTURE THE STANDING COMMITTEES OF THE SENATE.

PARAGRAPH 5: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A 2/3 VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
