## A BILL

TO ALLOCATE A MAXIMUM OF TWO THOUSAND THREE HUNDRED SIXTY-EIGHT DOLLARS AND FIFTY-FIVE CENTS (\$2,365.55) FROM THE STUDENT SENATE CONTINGENCY ACCOUNT TO THE EIGHT (8) MEMBERS OF THE NATIONAL ASSOCIATION OF WOMEN MBAS – LSU CHAPTER TO ATTEND THE NATIONAL ASSOCIATION OF WOMEN MBAS NATIONAL CONFERENCE IN CALIFORNIA ON OCTOBER 29<sup>TH</sup> – 31<sup>ST</sup>.

- PARAGRAPH 1:** WHEREAS, THE NATIONAL ASSOCIATION OF WOMAN MBAS (NAWMBA) IS AN ORGANIZATION THAT USES EDUCATION, PROFESSIONAL DEVELOPMENT, NETWORKING, AND COLLABORATION TO PROPEL MORE WOMEN INTO LEADERSHIP POSITIONS IN CORPORATE AMERICA AND TO ENHANCE THE DIVERSITY OF THE NATION'S WORKFORCE; AND
- PARAGRAPH 2:** WHEREAS, THE ORGANIZATION'S NATIONAL CONFERENCE IS HELD THIS YEAR IN ANAHEIM, CALIFORNIA, WHICH ALLOWS THE ATTENDEES TO MEET WITH COMPANIES, PRE-APPLY TO POSTED JOBS, AND RECEIVE TRAINING IN INTERVIEWING AND RESUME SKILLS; AND
- PARAGRAPH 3:** WHEREAS, THE ORGANIZATION WILL NOT RECEIVE FUNDS FROM THE GRADUATE SCHOOL BECAUSE THE CONFERENCE DOES NOT QUALIFY AS A RESEARCH CONFERENCE; AND
- PARAGRAPH 4:** WHEREAS, THESE INDIVIDUALS WILL INCUR GROUP COSTS OF APPROXIMATELY NINE HUNDRED FIFTY-FOUR DOLLARS (\$954.00) FOR ROOM AND BOARD AND ONE THOUSAND DOLLARS (\$1,000.00) FOR REGISTRATION; AND
- PARAGRAPH 5:** WHEREAS, THE MONEY ALLOCATED IN THIS WILL BE SPECIFICALLY USED TO DEFER THE COSTS OF TRAVEL TO THE CONFERENCE IN ANAHEIM.
- PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE THAT A MAXIMUM OF TWO THOUSAND THREE HUNDRED SIXTY-EIGHT DOLLARS AND FIFTY-FIVE CENTS (\$2,368.55) BE ALLOCATED FROM THE STUDENT SENATE CONTINGENCY ACCOUNT TO EIGHT MEMBERS OF THE NATIONAL ASSOCIATION OF WOMEN MBAS – LSU CHAPTER TO ATTEND THE NATIONAL ASSOCIATION OF WOMEN MBAS NATIONAL CONFERENCE.
- PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT; UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION; OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE.
