A RESOLUTION

TO RECOGNIZE AND COMMEND THE ENDLESS DEDICATION OF ERIC MONDAY AS INTERIM VICE CHANCELLOR FOR STUDENT LIFE

- PARAGRAPH 1: WHEREAS, SINCE TAKING THE POSITION, ERIC MONDAY HAS EXHIBITED A DEDICATION TO THE LSU COMMUNITY AND HAS TIRELESSLY WORKED TO ENHANCE THE LIFE OF THE CAMPUS ENVIRONMENT; AND
