**A RESOLUTION****TO CREATE THE TEMPORARY STUDENT GOVERNMENT POSTSECONDARY EDUCATION  
REVIEW COMMISSION**

**PARAGRAPH 1:** WHEREAS, THE TUCKER COMMISSION HAS BEEN CREATED TO STUDY AND DISCUSS THE FUTURE OF HIGHER EDUCATION; AND

**PARAGRAPH 2:** WHEREAS, THE ACTIONS OF THE TUCKER COMMISSION WILL DIRECTLY AFFECT THE FUTURE OF LOUISIANA STATE UNIVERSITY AND ITS STUDENTS; AND

**PARAGRAPH 3:** WHEREAS, THE TEMPORARY STUDENT GOVERNMENT POSTSECONDARY EDUCATION REVIEW COMMITTEE WOULD MEET TO DISCUSS THE INTERESTS OF THE TUCKER COMMISSION AND PROVIDE STUDENT OPINION ON THESE CRUCIAL MATTERS; AND

**PARAGRAPH 4:** WHEREAS, THIS COMMITTEE WOULD BE MADE UP OF :

- TWO (2) STUDENT SENATORS ELECTED FROM THE MEMBERSHIP OF THE SENATE
- THE DIRECTOR OF ACADEMICS, OR HIS/HER APPOINTEE; AND
- ONE (1) EXECUTIVE STAFF APPOINTMENT MADE BY THE STUDENT BODY PRESIDENT
- THE CHAIR OF THE SENATE COMMITTEE ON ACADEMICS, OR HIS/HER APPOINTEE; AND
- ONE (1) JUDICIAL BRANCH APPOINTMENT MADE BY THE CHIEF JUSTICE
- ONE (1) COLLEGE COUNCIL EXECUTIVE MEMBER APPOINTED BY THE CCPC; AND
- TWO (2) STUDENTS NOT AFFILIATED WITH STUDENT GOVERNMENT; APPOINTED BY PRESIDENT AND APPROVED BY THE SENATE
- THE STUDENT BODY PRESIDENT, SPEAKER OF THE SENATE, AND THE CHIEF JUSTICE OF THE UNIVERSITY COURT SHALL BE EX-OFFICIO MEMBERS;

**PARAGRAPH 5:** WHEREAS, ONE OF THE ABOVE MEMBERS SHALL BE ELECTED AND SERVE AS THE CHAIR OF THIS COMMITTEE, AND

**PARAGRAPH 6:** THEREFORE, BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE CREATES THIS COMMITTEE TO REVIEW AND DISCUSS THE INTERESTS OF THE TUCKER COMMISSION; AND

**PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT; UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION; OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE.
