A BILL

TO ALLOCATE ONE THOUSAND NINE HUNDRED AND EIGHT DOLLARS (\$1,908.00) FROM THE STUDENT SENATE CONTINGENCY ACCOUNT TO VOLUNTEER LSU TO HELP DEFER THE COST OF THE "SERVICE ON THE SHORE" MISSION TRIP.

PARAGRAPH 1: WHEREAS, A GROUP OF MORE THAN THIRTY STUDENTS WILL BE TRAVELING TO GALVESTON, TX FROM MARCH 6TH TO MARCH 8TH TO PARTICIPATE IN THE "SERVICE ON THE SHORE" MISSION TRIP; AND

PARAGRAPH 2: WHEREAS, THE PURPOSE OF THIS TRIP IS TO CONTINUE EFFORTS TOWARDS HELPING VICTIMS OF HURRICANE IKE; AND

PARAGRAPH 3: WHEREAS, THIS TRIP WILL ALLOW STUDENTS INVOLVED IN VOLUNTEER LSU TO PROMOTE AND COORDINATE VOLUNTEER OPPORTUNITIES, BUILD PARTNERSHIPS WITHIN THE COMMUNITY, INSTILL A LIFELONG COMMITMENT TO SERVICE, AND SHED LIGHT ON THE RECIPROCITY OF SERVICE; AND

PARAGRAPH 4: WHEREAS, THE INDIVIDUALS VOLUNTEERING HAVE MADE PERSONAL CONTRIBUTIONS OF FORTY DOLLARS (\$40) EACH TO HELP OFFSET THE COSTS OF HOUSING FOR THE MISSION TRIP.

PARAGRAPH 5: THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE THAT ONE THOUSAND NINE HUNDRED AND EIGHT DOLLARS (\$1,908.00) BE ALLOCATED FROM THE STUDENT SENATE CONTINGENCY ACCOUNT TO VOLUNTEER LSU TO HELP DEFER THE COST OF THE "SERVICE ON THE SHORE" MISSION TRIP.

PARAGRAPH 6: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2%) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
