## A BILL

TO AMEND THE 2008-2009 STUDENT GOVERNMENT BUDGET.

**PARAGRAPH 1:** WHEREAS, THIS BILL SHALL AMEND THE 2008-2009 STUDENT GOVERNMENT BUDGET TO REFLECT CHANGES IN THE ALLOCATIONS OF CERTAIN ACCOUNTS AS LISTED BELOW:

**PARAGRAPH 2: Section 2: EXECUTIVE OPERATIONAL EXPENSES**

These funds are appropriated to the control of the Student Government President and subject to notification of the Director of Finance and Chairman of the Committee on Finance. These funds shall be expended as follows:
