A BILL**TO AMEND ARTICLE VII, SECTION D OF THE STUDENT GOVERNMENT BYLAWS**

- PARAGRAPH 1:** WHEREAS, THE STUDENT GOVERNMENT CORPORATE SPONSORSHIP ACCOUNT IS PRIMARILY UNDER THE CONTROL OF THE STUDENT BODY PRESIDENT; AND
- PARAGRAPH 2:** WHEREAS, THE STUDENT BODY PRESIDENT AND THE EXECUTIVE STAFF HAVE AN OBLIGATION TO HONOR THE SPONSORSHIPS THAT HAVE BEEN GAINED, REGARDLESS OF SENATE APPROVAL; AND
- PARAGRAPH 3:** WHEREAS, THE FUNDRAISING PACKET FOR THE CORPORATE SPONSORSHIP ACCOUNT EXPLICITLY LISTS THOSE EVENTS THAT MUST BE FUNDED BY THESE SPONSORS; AND
- PARAGRAPH 4:** WHEREAS, THE PROPOSED CHANGE TO SECTION D, SUB-SECTION 1A WILL READ:
“HOWEVER, ANY COMBINED EXPENDITURE FROM THE STUDENT GOVERNMENT CORPORATE SPONSORSHIP ACCOUNT THAT IS NOT EXPLICITLY NAMED AND LISTED ON THE FUNDRAISING PACKET AND OTHER PRIVATE STUDENT GOVERNMENT ACCOUNTS SHALL BE APPROVED BY AN EXECUTIVE ORDER AS DEFINED IN THE STUDENT SENATE RULES OF ORDER SPECIFYING HOW THE MONEY WILL BE SPENT.”
- PARAGRAPH 5:** WHEREAS, WITH THIS CHANGE, A SUB-SECTION 1C WILL BE ADDED TO SECTION D WHICH WILL READ:
“THE CORPORATE SPONSORSHIP FUNDRAISING PACKET MUST BE APPROVED BY A MAJORITY VOTE OF THE STUDENT SENATE PRESENT AND VOTING AT THE SPRING SPECIAL ORGANIZATIONAL SESSION.”
- PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT ARTICLE VII, SECTION D OF THE STUDENT GOVERNMENT BYLAWS.
- PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
