**A RESOLUTION**  
**TO URGE AND REQUEST EXPERIENCE LSU TO REVIEW THE**  
**CURRENT FUNDRAISING METHODS FOR ORGNANZATIONS AND**  
**INVESTIGATE ALTERNATE METHODS OF FUNDRAISING**

- PARAGRAPH 1:** WHEREAS, ORGANIZATIONS WITHIN THE DEPARTMENT OF EXPERIENCE LSU HAVE PREVIOUSLY BEEN FULLY FUNDED FOR ORGANIZATION TRIPS THROUGH OUTSIDE FUNDRAISING; AND
- PARAGRAPH 2:** WHEREAS, IN 2017 AND 2018 ORGANIZATIONS HAVE HAD TO WAIT TO FUNDRAISE WITH SPECIFIC INSTRUCTIONS IN A SHORT AMOUNT OF TIME; AND
- PARAGRAPH 3:** WHEREAS, THE DEPARTMENT SHOULD BE FULLY EQUIPPED WITH OPTIONS TO FUNDRAISE OR RAISE MONEY, IF NOT, HAVE FUNDS SET ASIDE FOR THESE SPECIFIC ORGANIZATIONS TO USE; AND
- PARAGRAPH 4:** WHEREAS, EXPERIENCE LSU ORGANIZATIONS SHOULD NOT COME TO OTHER STUDENT ORGANIZATIONS TO FUNDRAISE IF THEIR DEPARTMENT HAS THE MEANS TO FUND; AND
- PARAGRAPH 5:** THEREFORE, BE IT RESOLVED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT EXPERIENCE LSU SHOULD OFFER AND REVIEW PREVIOUS METHODS OF FUNDRAISING FOR ORGANIZATIONS AND INVESTIGATE ALTERNATE METHODS OF FUNDRAISING, AND
- PARAGRAPH 6:** BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE TRANSMITTED TO CONNOR GONZALES, KELLI WEBBER, HEATHER HERMAN, JASON DRODDY, AND EXPERIENCE LSU STAFF ....
- PARAGRAPH 7:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY (ONE-HALF PLUS ONE) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
