A BILL

TO AMEND RULE 5.4 OF THE STUDENT GOVERNMENT RULES OF ORDER.

PARAGRAPH 1: WHEREAS, THE CURRENT RULE 5.4 STATES:

Rule 5.4 Referral to standing committees

All legislation, except Bill of Impeachment, shall be referred by the Speaker according to the topic matter as hereinafter set forth, **at least one** (1), appropriate standing committee listed herein; provided, however that at the time of referral any member may object to the referral and may move to assign the legislation to another committee named in the motion.

- A. Academics, Athletics, and Administration: to this committee shall be referred, in accordance with the rules, all legislation and other matters relating to the following subjects:
1. Academics and financial aid generally.
 2. Cultural and educational affairs and programs
 3. University-affiliated athletics and intramural sports generally
 4. University faculty, staff, and administrators
 5. Appropriation of Student Government funds by legislation, for purposes relating to Academics and Financial Aid, Athletics, and Administration, excluding the Student Government Budget Bill.
 6. All other matters as ordered by the Student Senate.
- B. Finance: To this committee shall be referred, in accordance with the rules, all legislation, and other matters relating to the following subjects:
1. The Student Government Budget Bill.
 2. Fiscal affairs of the Student Government, including expenditures by the Student Senate.
 3. Budgetary requirements and procedures.
 4. Deposit and investment of Student Government funds.
 5. Except as otherwise stated in these Rules of Order, salaries of Student Government employees.
 6. Revenue raising and revenue measures generally, both of the Student Government and of the College Councils.
 7. Management of Student Government records.
 8. Other matters as ordered by the Student Senate.
- C. Governmental Relations: To this committee shall be referred all legislation and other matters relating to the following subjects:
1. External affairs of the Student Government.
 2. Relations between the Student Government and the state government, the city-parish government, other student governments, and national student associations, including, but not limited to the Louisiana Council of Student Body Presidents, the Council of Student Government Associations, the SEC Student Government Conference
 3. School and College Council affairs generally.
 4. Public relations of the Student Government.
 5. Student groups and organizations.
 6. Entertainment events and organizations.
 7. Appropriations of the Student Government for purposes relating to governmental relations, except the Student Government Budget Bill.
 8. All matters pertaining to Free Speech Alley.
 9. Other matters as ordered by the Student Senate.

D. Housing, Infrastructure, and Technology: To this committee shall be referred all legislation and other matters relating to the following subjects:

1. All matters relating to on-campus and off-campus housing, including the Residence Halls, Sorority housing, Fraternity housing, and apartment housing
2. The construction, demolition, or modification of structures or areas on campus
3. Facility Planning
4. Facility Services
5. The Information Technology Master Plan
6. The University Master Plan
7. The purchase, sale, modification, or use of university technology
8. Information Technology Services
9. The Student Technology Fee, with the exception of increases or decreases of the Fee itself
10. Appropriations of the Student Government for purposes relating to housing, infrastructure, or technology except the Student Government Budget Bill
11. Other matters as ordered by the Student Senate

E. Rules: To this committee shall be referred all legislation and other matters relating to the following subjects:

1. Services of or for the Student Senate, its members and/or its committees.
2. All Constitution and/or Bylaw amendments.
3. Legislative rules and procedures.
4. Elections and Election Board.
5. Appointment of persons to office in the Student Government.
6. Other matters as ordered by the Student Senate.

F. Student Rights and Welfare: To this committee shall be referred all legislation and other matters relating to the following subjects:

1. All matters relating to student-related auxiliaries.
2. Code of Student Conduct.
3. Bill of Student Rights.
4. University disciplinary regulations.
5. University traffic regulations.
6. Appropriations of Student government funds for purposes relating to student rights and welfare, excluding the Student Government Budget Bill.
7. LSU Student Government Textbook Exchange.
8. Other matters as ordered by the Student Senate.

PARAGRAPH 2: WHEREAS, THE NEW AMENDED RULES 5.4 WOULD STATE:

Rule 5.4 Referral to standing committees

All legislation, except Bill of Impeachment, shall be referred by the Speaker according to the topic matter as hereinafter set forth to **at least one (1)** appropriate standing committee listed herein; provided, however that at the time of referral any member may object to the referral and may move to assign the legislation to another committee named in the motion.

 13. Other matters as ordered by the Student Senate
- E. Rules: To this committee shall be referred all legislation and other matters relating to the following subjects:

 2. All Constitution and/or Bylaw amendments.
 3. Legislative rules and procedures.
 4. Elections and Election Board.
 5. Appointment of persons to office in the Student Government.
 6. Other matters as ordered by the Student Senate.
- F. Student Rights and Welfare: To this committee shall be referred all legislation and other matters relating to the following subjects:
1. All matters relating to student-related auxiliaries.
 2. Code of Student Conduct.
 3. Bill of Student Rights.
 4. University disciplinary regulations.
 5. ~~University traffic regulations.~~
 6. Appropriations of Student government funds for purposes relating to student rights and welfare, excluding the Student Government Budget Bill.
 7. **Financial Aid.**

8. Cultural affairs and programs.
9. All matters pertaining to public health.
10. All matters pertaining to students' constitutional rights and civil liberties.
11. Other matters as ordered by the Student Senate.

PARAGRAPH 3: THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE THAT AMEND RULE 5.4 OF THE STUDENT GOVERNMENT RULES OF ORDER.

PARAGRAPH 4: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
