A BILL

TO APPROPRIATE THIRTY-SEVEN THOUSAND FIVE HUNDRED NINETY DOLLARS (\$37,590.00) FROM THE STUDENT GOVERNMENT SURPLUS ACCOUNT TO PURCHASE FURNITURE FOR THE NEW STUDENT GOVERNMENT OFFICES.

PARAGRAPH 1: WHEREAS, STUDENT UNION CONSTRUCTION WILL SOON BE COMPLETED ON THE NEW EXECUTIVE AND SENATE OFFICES IN THE NEW WING OF THE LSU STUDENT UNION; AND

PARAGRAPH 2: WHEREAS, THE NEW OFFICES MUST BE FURNISHED TO MEET THE NEEDS OF STUDENT GOVERNMENT MEMBERS; AND

PARAGRAPH 3: WHEREAS, NEW FURNITURE IS NEEDED TO COMPLETE THE SPACE, AND OLD FURNITURE SHALL BE SURPLUSED ACCORDING TO UNIVERSITY PROCEDURES.

PARAGRAPH 4: THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE THAT THIRTY-SEVEN THOUSAND FIVE HUNDRED NINETY DOLLARS (\$37,590.00) BE APPROPRIATED FROM THE STUDENT GOVERNMENT SURPLUS ACCOUNT FOR THE PURCHASE OF NEW FURNITURE FOR THE NEW STUDENT GOVERNMENT OFFICES.

PARAGRAPH 5: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
