8 TO AMEND ARTICLE II, SECTION 1 OF THE STUDENT GOVERNMENT BYLAWS

10 **PARAGRAPH 1:** WHEREAS, CURRENTLY IN THE STUDENT GOVERNMENT BYLAWS  
11 THE ONLY WAY A SENATOR LOSES THEIR SENATE SEAT IS EITHER  
12 BY MISSING 3 SENATE MEETINGS OR MISSING 3 SENATE  
13 COMMITTEE MEETINGS IN ONE LEGISLATIVE SESSION, AND

14  
15 **PARAGRAPH 2:** WHEREAS, THE BYLAWS CURRENTLY READ:

16  
17 **SECTION 1. Student Senate; causes for removal of a member**

18  
19 **A member of the Student Senate shall be removed from**  
20 **his/her position on the Student Senate once he/she has accumulated a**  
21 **total of three (3) absences from regular meetings of the Student**  
22 **Senate per session or three (3) absences from his or her assigned**  
23 **committee per session.**

25 **PARAGRAPH 2:** WHEREAS, THIS BILL WOULD REMOVE A SENATOR FROM THEIR  
26 SENATE SEAT IF THEY WERE REMOVED FROM THEIR COLLEGE  
27 COUNCIL FOR ANY REASON, AND

29 **PARAGRAPH 3:** WHEREAS, THE REVISED BYLAWS WOULD READ:

30  
31 **SECTION 1. Student Senate; causes for removal of a member**

32  
33 **A member of the Student Senate shall be removed from**  
34 **his/her position on the Student Senate once he/she has accumulated a**  
35 **total of three (3) absences from regular meetings of the Student**  
36 **Senate per session, three (3) absences from his/her assigned**  
37 **committee per session, or removal from his/her respective college**  
38 **council according to the College Council Constitution. If a senator**  
39 **cannot attend the College Council meeting at the set time for any**  
40 **reason, the senator may meet with the College Council President at a**  
41 **time convenient to them. This makeup meeting shall not count as an**  
42 **absence.**

44 **PARAGRAPH 4:** THIS BILL SHALL TAKE EFFECT AT THE BEGINNING OF THE 2009-  
45 2010 ACADEMIC SCHOOL YEAR UPON PASSAGE BY A TWO-THIRDS  
46 (2/3) VOTE OF THE LSU A&M STUDENT SENATE AND SIGNATURE  
47 BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION,  
48 OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY  
49 THE SENATE, ON THE DATE OF SUCH APPROVAL.
