**LOUISIANA STATE UNIVERSITY****STUDENT SENATE****F08RS****SGR No. 2****BY: SENATORS BONVILLAIN, WISHIK, AND EASON****A RESOLUTION****TO URGE AND REQUEST THAT CLASS DAYS TO BE MADE UP AS A RESULT OF HURRICANE GUSTAV BE RESCHEDULED IN A MORE UNIFORM MANNER.**

**PARAGRAPH 1:** WHEREAS, LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE CANCELLED CLASS TUESDAY, SEPTEMBER 2 THROUGH FRIDAY, SEPTEMBER 5, 2008, IN RESPONSE TO HURRICANE GUSTAV; AND

**PARAGRAPH 2:** WHEREAS, THESE FOUR CLASS DAYS MUST BE MADE UP WITHIN THE TIME CONSTRAINTS OF THE FALL 2008 SEMESTER; AND

**PARAGRAPH 3:** WHEREAS, THE CLASS DAY CANCELLED ON TUESDAY, SEPTEMBER 2, 2008, IS TO BE RESCHEDULED ON EITHER SATURDAY, SEPTEMBER 20 OR SATURDAY, OCTOBER 11, 2008, AT THE DISCRETION OF THE PROFESSOR; AND

**PARAGRAPH 4:** WHEREAS, THE CLASS DAY CANCELLED ON WEDNESDAY, SEPTEMBER 3, 2008, IS TO BE RESCHEDULED ON EITHER SATURDAY, OCTOBER 4 OR SATURDAY, OCTOBER 18, 2008, AT THE DISCRETION OF THE PROFESSOR; AND

**PARAGRAPH 5:** WHEREAS, THE CLASS DAYS THAT WERE CANCELLED ON THURSDAY, SEPTEMBER 4 AND FRIDAY SEPTEMBER 5, 2008, ARE TO BE RESCHEDULED DURING FALL BREAK WHICH WAS PREVIOUSLY SCHEDULED FOR THURSDAY, OCTOBER 9 AND FRIDAY, OCTOBER 10, 2008; AND

**PARAGRAPH 6:** WHEREAS, FALL BREAK WAS IMPLEMENTED IN 1996 TO RELIEVE THE STUDENTS FROM THE STRESS OF HAVING TO ATTEND CLASS WITHOUT A HOLIDAY APPROXIMATELY TWELVE CONSECUTIVE WEEKS FROM LABOR DAY UNTIL THANKSGIVING; AND

**PARAGRAPH 7:** WHEREAS, MANY STUDENTS HAVE ALREADY MADE TRAVEL ARRANGEMENTS TO RETURN HOME FOR FALL BREAK AND OTHER WEEKENDS THROUGHOUT THE FALL SEMSTER; AND

**PARAGRAPH 8:** WHEREAS, STUDENTS MAY HAVE SET WORK SCHEDULES THEY MAY NOT BE ABLE TO ALTER AND THAT MAY INTERFERE WITH RESCHEDULED CLASS TIMES OR DATES; AND

**PARAGRAPH 9:** THEREFORE, BE IT RESOLVED THAT THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND MECHANICAL COLLEGE URGES AND REQUESTS THAT THESE FOUR CLASS DAYS BE RESCHEDULED





**PARAGRAPH 12:** THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT; UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION; OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE.
