9 **TO URGE THE STUDENT REQUIRED FEE ADVISORY COMMITTEE TO RECOMMEND A**  
10 **FEE ADJUSTMENT OF SEVENTEEN (\$17.00) DOLLARS FISCAL YEAR 09-10, SEVENTEEN**  
11 **(\$17.00) DOLLARS FISCAL YEAR 10-11, AND SEVENTEEN (\$17.00) DOLLARS FISCAL**  
12 **YEAR 11-12.**

15 **PARAGRAPH 1:** WHEREAS, THE STUDENT REQUIRED FEE ADVISORY  
16 COMMITTEE WAS ADDRESSED BY THE STUDENT HEALTH CENTER  
17 FOR A FEE ADJUSTMENT; AND

19 **PARAGRAPH 2:** WHEREAS, THE STUDENT HEALTH CENTER REQUESTED A  
20 TWENTY (\$20.00) DOLLAR INCREASE FISCAL YEAR 07-08 ; AND

21  
22 **PARAGRAPH 3:** WHEREAS, THE STUDENT REQUIRED FEE ADVISORY  
23 COMMITTEE DECREASED THE FEE THREE (\$3.00) DOLLARS.

25 **PARAGRAPH 4:** THEREFORE, BE IT RESOLVED THAT THE STUDENT  
26 GOVERNMENT OF LOUISIANA STATE UNIVERSITY  
27 AGRICULTURAL AND MECHANICAL COLLEGE TO URGE  
28 THE STUDENT REQUIRED FEE ADVISORY COMMITTEE TO  
29 RECOMMEND A FEE ADJUSTMENT OF SEVENTEEN (\$17.00)  
30 DOLLARS FISCAL YEAR 09-10, SEVENTEEN (\$17.00) DOLLARS  
31 FISCAL YEAR 10-11, AND SEVENTEEN (\$17.00) DOLLARS FISCAL  
32 YEAR 11-12.

34 **PARAGRAPH 5:** BE IT FURTHER RESOLVED THAT THIS BE SENT TO THE  
35 STUDENT REQUIRED FEE ADVISORY COMMITTEE.

37 **PARAGRAPH 6:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY  
38 (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY  
39 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
40 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
41 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
