A BILL

TO ALLOCATE FOUR THOUSAND DOLLARS (\$4000) FROM THE INITIATIVES ACCOUNT TO THE DEPARTMENT OF FRENCH STUDIES TO HELP DEFRAY THE COSTS OF HOSTING THE CHARITABLE FASHION SHOW, "ATHLETICA: A TRIBUTE TO SPORT."

PARAGRAPH 1: WHEREAS, THE DEPARTMENT OF FRENCH STUDIES HAS BEGUN TO HOST AN ANNUAL FASHION SHOW WITH ALL PROCEEDS GOING TO SCHOLARSHIPS; AND,

PARAGRAPH 2: WHEREAS, THESE SCHOLARSHIPS PROVIDE A ONCE IN A LIFETIME LEARNING OPPORTUNITY FOR AN LSU STUDENT TO BOTH STUDY AND LIVE IN FRANCE; AND,

PARAGRAPH 3: WHEREAS, THIS FASHION SHOW WILL PROVIDE AN OPPORTUNITY FOR LOCAL BOUTIQUES TO HIGHLIGHT THEIR COLLECTIONS; AND,

PARAGRAPH 4: WHEREAS, THERE ARE COSTS ASSOCIATED WITH HOLDING THE FASHION SHOW, INCLUDING BUT NOT LIMITED TO: VENUE, FOOD, PROMOTION, ETC.; AND,

PARAGRAPH 5: WHEREAS, THE STUDENTS OF FRENCH STUDIES INVOLVED IN PLANNING ATHLETICA WILL BENEFIT EDUCATIONALLY AND PROFESSIONALLY.

PARAGRAPH 6: THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE WILL ALLOCATE FOUR THOUSAND DOLLARS (\$4000) FROM THE INITIATIVES ACCOUNT TO THE DEPARTMENT OF FRENCH STUDIES, IN ITS EFFORTS TO FURTHER REPRESENT OUR UNIVERSITY.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
