15 **PARAGRAPH 1:** WHEREAS, THE CADGIS RESEARCH LABORATORY HAS BEEN
16 WORKING ON THE PRODUCTION OF A NEW ONLINE CAMPUS MAP
17 FOR NEARLY THREE YEARS; AND,

19 **PARAGRAPH 2:** WHEREAS, ONE MAJOR PROBLEM WITH THE MAP CURRENTLY
20 AVAILABLE ONLINE IS ITS LACK OF ACCESSIBILITY AND OUTDATED
21 DATA REGARDING THE CONTINUOUS CONSTRUCTION AND
22 UPDATES BEING MADE TO OUR CAMPUS; AND,

24 **PARAGRAPH 3:** WHEREAS, THE NEW MAP WILL PROVIDE A GREATER LEVEL OF
25 ACCESSIBILITY, INCLUDING INFORMATION REGARDING BUS
26 ROUTES; AS WELL AS OTHER INTEGRATED, INTERACTIVE OPTIONS;

29 **PARAGRAPH 4:** WHEREAS, THIS INCREASED LEVEL OF TECHNOLOGY WILL HAVE
30 THE CAPACITY TO EVENTUALLY INCORPORATE OTHER

45 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND
46 SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF
