8 TO APPROPRIATE FUNDS OF THE STUDENT SENATE CONTINGENCY TO HELP WITH  
9 COSTS ASSOCIATED WITH A GRAD STUDENT ATTENDING A CONFERENCE.

12 **PARAGRAPH 1:** WHEREAS, MELISSA WILKINSON, A GRADUATE STUDENT AT  
13 LSU HAS BEEN INVITED TO PRESENT AT A CONFERENCE IN NEW  
14 YORK, NEW YORK TITLED, "WRITING MY DEGREES," AND

15  
16 **PARAGRAPH 2:** WHEREAS, THERE IS A NEED TO FUND SUCH INITIATIVES AS IT  
17 WILL REPRESENT THE UNIVERSITY IN A POSITIVE MANNER ON THE  
18 NATIONAL STAGE, AND ENRICH THE LEVEL OF EDUCATION FOR  
19 THE GRADUATE STUDENT ATTENDING THE CONFERENCE, AND

20  
21 **PARAGRAPH 3:** WHEREAS, IN KEEPING WITH THE UNIVERSITY'S FLAGSHIP  
22 AGENDA AND EXAPND THE LEVEL RESEARCH, THERE IS A NEED TO  
23 CONTINUE TO FUND ATTENDANCE AT CONFERENCES, AND

26 **PARAGRAPH 4:** THEREFORE, BE IT ENACTED BY THE STUDENT  
27 SENATE OF LOUISIANA STATE UNIVERSITY  
28 AGRICULTURAL AND MECHANICAL COLLEGE THAT  
29 THE AMOUNT OF FIVE HUNDRED (\$500)DOLALRS BE ALLOCATED  
30 FROM THE STUDENT SENATE CONTINGENCY FOR LODGING AND  
31 TRAVEL EXPENSES ASSOCIATED WITH THE ATTENDANCE OF  
32 MELISSA WILKINSON AT THE "WRITING MY DEGREES"  
33 CONFERENCE IN NEW YORK, NEW YORK.

35 **PARAGRAPH 5:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY  
36 (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY  
37 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
38 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
39 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
