8 TO AMEND RULES OF THE STUDENT SENATE RULES OF ORDER TO PROVIDE FOR
9 ATTENDANCE RECORDS AND RELATED MATTERS

10 THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF
11 LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL
12 COLLEGE

13 PARAGRAPH 1: RULE 5.10 OF THE STUDENT SENATE RULES OF ORDER TO BE
14 AMENDED AS FOLLOWS:

15 Rule 5.10 Committee report

16 A. Each standing committee shall submit a written report to the Secretary as
17 soon as possible after each committee meeting. The report must list:

- 18 1. The name of the committee.
- 19 2. The date, time, and place of the committee meeting.
- 20 3. Names of committee members present, absent, and proxies.
- 21 4. The number of each piece of legislation and report on it.
- 22 5. The vote by which such report was determined.
- 23 6. An update on the committee's progress in meeting its strategic plan.
- 24 7. A summary of discussion at the last public forum, if one was held
25 since the last meeting of the senate.

26 PARAGRAPH 2: RULE 10.1 OF THE STUDENT SENATE RULES OF ORDER TO BE
27 AMENDED AS FOLLOWS:

28 Rule 10.1 Proceedings entered therein

29 The proceedings of the Senate shall be taken to detail a true and accurate
30 account of the proceedings. Roll calls taken at the beginning and ending of these
31 proceedings must be entered in said Minutes with a detailed account listing
32 members present and absent. Approved excused absences shall be noted as such in
33 said Minutes.

34 PARAGRAPH 3: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS
35 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
36 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
37 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
38 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
