A BILL

TO APPROPRIATE TWO THOUSAND ONE HUNDRED SEVENTY- ONE DOLLARS AND EIGHTY-THREE CENTS (\$2171.83) TO THE MASTER OF BUSINESS ADMINISTRATION ASSOCIATION (MBAA) TO DEFRAY THE COST OF SENDING FORTY (40) STUDENTS TO THE FLORES MBA E. J. OURSO COLLEGE OF BUSINESS CAREER FAIR IN HOUSTON, TX ON NOVEMBER 18, 2005.

- PARAGRAPH 1:** WHEREAS, THE MBAA IS AN OFFICIAL RECOGNIZED STUDENT ORGANIZATION IN GOOD STANDING AT LOUISIANA STATE UNIVERSITY, AND
- PARAGRAPH 2:** WHEREAS, THE MBAA CONTINUALLY REPRESENTS THE FLORES MASTER OF BUSINESS ADMINISTRATION PROGRAM AND THE E. J. OURSO COLLEGE OF BUSINESS TO THE BEST OF ITS ABILITY, AND
- PARAGRAPH 3:** WHEREAS, THE TOTAL COST OF TRANSPORTATION FOR FORTY (40) STUDENTS TO ATTEND THE CAREER FAIR IS TWO THOUSAND ONE HUNDRED SEVENTY- ONE DOLLARS AND EIGHTY-THREE CENTS (\$2171.83), AND
- PARAGRAPH 4:** WHEREAS, THE ABOVE MENTIONED CAREER RECEPTION IS SPONSORED AND HOSTED BY JAMES FLORES IN HIS OFFICE IN HOUSTON, TX, DUE TO THE IMPACT AND AFTERMATH CONDITIONS OF HURRICANES KATRINA AND RITA, AND
- PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE STUDENT GOVERNMENT OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE HEREBY APPROPRIATE TWO THOUSAND ONE HUNDRED SEVENTY- ONE DOLLARS AND EIGHTY-THREE CENTS (\$2171.83) TO THE MBAA TO HELP DEFRAY THE COST OF TRANSPORTATION FOR FORTY (40) STUDENTS TO THE CAREER RECEPTION NOVEMBER 18, 2005 IN HOUSTON, TX.
- PARAGRAPH 6:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
- PARAGRAPH 7:** ALL MONIES NOT EXPENDED BY THE END OF THE 2005 SPRING ACADEMIC SEMESTER WILL REVERT TO THE SENATE GENERAL CONTINGENCY. SHOULD ANY PROVISION OF ARTICLE VI SECTIONS 14 THROUGH 17 OF THE STUDENT GOVERNMENT BYLAWS BE VIOLATED, RIGHTS TO GRANTED FUNDING WILL BE FORFEITED AND THIS BILL SHALL BECOME NULL AND VOID, UNLESS OTHERWISE PROVIDED IN THE RULES.
