A BILL

TO APPROPRIATE ONE THOUSAND TWO HUNDRED THIRTY-FIVE DOLLARS AND TEN CENTS (\$1,235.10) TO THE NATIONAL STUDENT SPEECH LANGUAGE HEARING ASSOCIATION OF LSU (NSSLHA) TO HELP DEFRAY THE COST OF ATTENDING THE ANNUAL AMERICAN SPEECH LANGUAGE HEARING ASSOCIATION (ASHA) CONVENTION IN NEW ORLEANS ON NOVEMBER 15-18, 2001.

- PARAGRAPH 1:** WHEREAS, THE NATIONAL STUDENT SPEECH LANGUAGE HEARING ASSOCIATION OF LSU (NSSLHA) IS A RECOGNIZED STUDENT ORGANIZATION IN GOOD STANDING, AND
- PARAGRAPH 2:** WHEREAS, MEMBERSHIP IN NSSLHA DELIVERS AN OUT OF THE CLASSROOM EXPERIENCE FOR BOTH GRADUATE AND UNDER-GRADUATE STUDENTS THROUGH CASE CHATS, WHICH PROVIDE PROFESSIONAL DEVELOPMENT IN AUDIOLOGY AND SPEECH-LANGUAGE PATHOLOGY, AND
- PARAGRAPH 3:** WHEREAS, ATTENDANCE AT THE ANNUAL ASHA CONVENTION WILL PROVIDE AN OPPORTUNITY FOR NSSLHA MEMBERS TO DEVELOP PROFESSIONAL RELATIONSHIPS WITH SOME OF THE MOST RENOWN SPEECH-LANGUAGE PATHOLOGISTS AND AUDIOLOGISTS IN THE NATION, AND
- PARAGRAPH 4:** WHEREAS, THE LSU CHAPTER OF NSSLHA WILL BE REPRESENTED IN SEVERAL PRESENTATIONS AT THE CONFERENCE, AND
- PARAGRAPH 5:** WHEREAS, ATTENDANCE AT THE CONFERENCE IS NOT MANDATORY FOR MEMBERS, BUT IS HIGHLY RECOMMENDED, AND
- PARAGRAPH 6:** WHEREAS, THE MEMBERS OF LSU CHAPTER OF NSSLHA WILL BE COVERING ALL EXPENSES ASSOCIATED FROM THE CONVENTION OUT OF THEIR OWN POCKET.
- PARAGRAPH 7:** THEREFORE, THE LSU A&M STUDENT SENATE DOES HEREBY APPROPRIATE ONE THOUSAND TWO HUNDRED THIRTY-FIVE DOLLARS AND TEN CENTS (\$1,235.10) TO THE NATIONAL STUDENT SPEECH LANGUAGE HEARING ASSOCIATION OF LSU TO HELP DEFRAY THE COST OF ATTENDING THE ANNUAL AMERICAN SPEECH LANGUAGE HEARING ASSOCIATION CONVENTION IN NEW ORLEANS ON NOVEMBER 15-18, 2001.

PARAGRAPH 8: ALL MONIES NOT USED SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 2002.

PARAGRAPH 9: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY VOTE OF THE LSU A&M STUDENT SENATE.
