A RESOLUTION

TO CREATE A COMMITTEE TO EVALUATE A RECREATIONAL SPORTS COMPLEX FEE INCREASE.

PARAGRAPH 1: WHEREAS, THE RECREATIONAL SPORTS COMPLEX HAS BEEN FORCED TO CURTAIL OPERATING HOURS THIS SEMESTER DUE TO INCREASED OPERATING COSTS, AND

PARAGRAPH 2: WHEREAS, A LARGE MAJORITY OF FUNDING TO THE RECREATIONAL SPORTS COMPLEX COMES FROM A CURRENT STUDENT SELF-ASSESSED FEE OF THIRTY DOLLARS (\$30.00) PER SEMESTER, AND

PARAGRAPH 3: WHEREAS, THE RECREATIONAL SPORTS COMPLEX HAS ALSO EXPRESSED A DESIRE TO EXPAND, AS EVIDENCED BY THE RESULTS OF THE RECENT ONLINE STUDENT SURVEYS, AND

PARAGRAPH 4: WHEREAS, THE MEMBERSHIP OF THE STUDENT GOVERNMENT COMMITTEE TO EVALUATE THE RECREATIONAL SPORTS COMPLEX FEE SHALL CONSIST OF THE FOLLOWING:

1. SPEAKER OF THE SENATE.
2. STUDENT BODY PRESIDENT.
3. TWO (2) MEMBERS TO BE APPOINTED BY THE SPEAKER OF THE SENATE.
4. TWO (2) MEMBERS TO BE APPOINTED BY THE STUDENT BODY PRESIDENT.
5. ONE (1) MEMBER THAT IS A LAW STUDENT TO BE APPOINTED BY THE PRESIDENT OF THE STUDENT BAR ASSOCIATION.
6. THE CHAIR OF THE RECREATIONAL SPORTS ADVISORY COUNCIL.
7. THE TWO (2) MEMBERS OF THE RECREATIONAL SPORTS ADVISORY COUNCIL ELECTED IN THE FALL 2001 ELECTION.
8. ONE (1) MEMBER TO BE ELECTED FROM THE CLUB SPORTS ADVISORY BOARD.
9. ONE (1) MEMBER TO BE APPOINTED BY THE PRESIDENT OF THE GRADUATE STUDENT ASSOCIATION.

PARAGRAPH 5: WHEREAS, TOTAL VOTING MEMBERSHIP OF THE COMMITTEE IS TWELVE (12), AND QUORUM NEEDED TO CONDUCT BUSINESS IS SEVEN (7), AND THE COMMITTEE SHALL ELECT ITS OWN CHAIR AT THE FIRST MEETING, AND

PARAGRAPH 6: WHEREAS, THIS COMMITTEE WILL BEGIN UPON PASSAGE OF THIS LEGISLATION AND CONCLUDE WHEN THE COMMITTEE DEEMS NECESSARY,

NOT TO EXCEED THE SPRING 2002 SEMESTER. MEETING TIMES AND DATES WILL BE DETERMINED AFTER ITS FORMATION.

PARAGRAPH 7: THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE CREATES THE STUDENT GOVERNMENT COMMITTEE TO EVALUATE THE RECREATIONAL SPORTS COMPLEX FEE.
