**A BILL**

**TO AMEND ARTICLE IV, SECTION 3 OF THE LSU A&M STUDENT  
GOVERNMENT ELECTION CODE AS IT PERTAINS TO PROHIBITED METHODS OF  
CAMPAIGNING.**

**PARAGRAPH 1:** ARTICLE IV, SECTION 3, SUBSECTION E SHALL BE ADDED TO THE ELECTION CODE, AND

**PARAGRAPH 2:** THEREFORE BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE AMENDS ARTICLE IV, SECTION 3, OF THE STUDENT GOVERNMENT ELECTION CODE TO READ AS FOLLOWS:

“THE FOLLOWING METHODS OF CAMPAIGNING MAY NOT BE USED:

- A. AIRCRAFT;
- B. LOUDSPEAKERS, SIRENS, OR OTHER NOISEMAKERS (EXCEPT AT RALLIES NOT ON ELECTION DAYS);
- C. ADVERTISING ON ANY RADIO, NEWSPAPER OR TELEVISION MEDIUM;
- D. DECORATING ANY CAR WITHOUT THE EXPRESS CONSENT OF THE OWNER.
- E. UNSOLICITED E-MAILS TO STUDENTS.”

**PARAGRAPH 3:** THIS BILL SHALL BECOME EFFECTIVE IN TWO (2) SEMESTERS, EXCLUDING SUMMERS, FOLLOWING PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE STUDENT SENATE.
