A BILL

TO AMEND THE STUDENT GOVERNMENT 2000-2001 FISCAL YEAR BUDGET.

PARAGRAPH 1: WHEREAS, ARTICLE VI, SECTION 6 OF THE STUDENT GOVERNMENT BYLAWS ALLOWS FOR THE STUDENT GOVERNMENT BUDGET TO BE AMENDED BY A SIMPLE MAJORITY VOTE OF THE STUDENT SENATE PRESENT AND VOTING, AND

PARAGRAPH 2: WHEREAS, THE ADMINISTRATIVE LIAISON IS CURRENTLY WITHOUT AN APPROPRIATED SALARY, AND

PARAGRAPH 3: WHEREAS, THE DEPARTMENT OF STUDENT INVOLVEMENT IS CURRENTLY WITHOUT APPROPRIATED FUNDS.

PARAGRAPH 4: THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE DOES HEREBY AMEND THE STUDENT GOVERNMENT 2000-2001 FISCAL YEAR BUDGET TO INCORPORATE THE FOLLOWING CHANGES:

ITEM 3 "EXECUTIVE VICE PRESIDENT" SHALL BE AMENDED TO READ "ADMINISTRATIVE LIAISON" WITH SALARY ADJUSTED TO \$350.00.

ITEM 22 PRESIDENT'S CONTINGENCY APPROPRIATED AMOUNT SHALL BE ADJUSTED TO \$7,928.28.

SECTION 15: DIVISION OF STUDENT INVOLVEMENT SHALL BE INSERTED IN PARAGRAPH 2.

ITEM 46 STUDENT INVOLVEMENT EXPENDITURES SHALL BE INSERTED IN PARAGRAPH 2, SECTION 15 WITH APPROPRIATED AMOUNT ADJUSTED TO \$1000.00.

ITEM 73 LEGISLATIVE BRANCH GENERAL CONTINGENCY APPROPRIATED AMOUNT SHALL BE ADJUSTED TO \$18,312.41.

ALL BRANCH TOTALS AND ITEM NUMBERS SHALL BE ADJUSTED ACCORDINGLY.

PARAGRAPH 5: THIS BILL SHALL BECOME EFFECTIVE UPON PASSAGE BY MAJORITY VOTE OF THE LSU A&M STUDENT SENATE PRESENT AND VOTING.
