**A BILL**

TO APPROPRIATE EIGHT HUNDRED FORTY-EIGHT DOLLARS AND FIFTY-FIVE CENTS (\$848.55) TO THE LSU VOLLEYBALL CLUB TO COVER THE COST OF EQUIPMENT.

**PARAGRAPH 1:** WHEREAS, THE LSU VOLLEYBALL CLUB HAS BEEN A REGISTERED STUDENT ORGANIZATION SINCE FALL 1998, AND

**PARAGRAPH 2:** WHEREAS, THE TEAM HAS BEEN PROVIDED WITH TWO HUNDRED FIFTY DOLLARS (\$250.00) OF FUNDING AND NO EQUIPMENT BY RECREATIONAL SPORTS, AND

**PARAGRAPH 3:** WHEREAS, THE TEAM MUST USE ITS SELF-GENERATED FUNDS TO GO TO TOURNAMENTS, AND

**PARAGRAPH 4:** WHEREAS, THE TEAM IS LEFT WITH NO FINANCIAL MEANS OF COVERING THE COST OF EQUIPMENT.

**PARAGRAPH 5:** THEREFORE, THE LSU A&M STUDENT SENATE HEREBY APPROPRIATES EIGHT HUNDRED FORTY-EIGHT DOLLARS AND FIFTY-FIVE CENTS (\$848.55) TO THE LSU VOLLEYBALL CLUB TO COVER THE COST OF EQUIPMENT.

**PARAGRAPH 6:** ALL MONIES NOT USED SHALL REVERT TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 2000.
