A RESOLUTION

**TO RECOMMEND TO THE LSU A&M CHANCELLOR, PROVOST, AND REGISTRAR
A REALLOCATION OF COURSE SCHEDULING PRIORITIES .**

PARAGRAPH 1: WHEREAS, THE CURRENT SCHEDULING SYSTEM FAILS TO FULLY RECOGNIZE THE DIFFERENT ACADEMIC NEEDS OF STUDENTS WITH FEWER THAN SIXTY (60) HOURS, AND

PARAGRAPH 2: WHEREAS, THE CURRENT SYSTEM CANNOT ADEQUATELY AND FAIRLY HANDLE THE VOLUME OF SCHEDULING REQUESTS DURING THE LATTER SCHEDULING PRIORITIES, AND

PARAGRAPH 3: WHEREAS, THE SCHEDULING SYSTEM SHOULD BE FAIR AND REASONABLY ACCESSIBLE FOR ALL STUDENTS.

PARAGRAPH 4: THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE RECOMMENDS TO THE CHANCELLOR, PROVOST, AND REGISTRAR THE FOLLOWING CHANGES IN THE COURSE SCHEDULING PRIORITY:

PH1D: FOR STUDENTS WHO HAVE FORTY-FIVE (45) SEMESTER HOURS (HOURS EARNED + HOURS CARRIED = 45)

PH1E: FOR STUDENTS WHO HAVE THIRTY (30) SEMESTER HOURS (HOURS EARNED + HOURS CARRIED = 30)

PH1F: FOR STUDENTS WHO HAVE FIFTEEN (15) SEMESTER HOURS (HOURS EARNED + HOURS CARRIED = 15)

PH1G: FOR STUDENTS WITH FEWER THAN FIFTEEN (15) HOURS (HOURS EARNED + HOURS CARRIED < 15)
