A RESOLUTION

TO CREATE A SYSTEM WHEREBY STUDENT GOVERNMENT CAN MORE EFFECTIVELY LOBBY FOR BETTER LIGHTING, AND BOTH AID AND MONITOR FACILITY SERVICES IN MAINTAINING LIGHTING AND SAFETY ON CAMPUS.

- PARAGRAPH 1:** WHEREAS, MANY STUDENTS EXPRESS AN ONGOING CONCERN WITH LIGHTING AND SAFETY ON CAMPUS, AND
- PARAGRAPH 2:** WHEREAS, LIGHTING IN IMPORTANT AREAS OF CAMPUS HAS GONE UNATTENDED AND REMAINED INOPERABLE FOR MONTHS, AND
- PARAGRAPH 3:** WHEREAS, THERE IS NO EXISTING MONTHLY CHECK ON THE STATE OF LIGHTING ON CAMPUS AT NIGHT, AND
- PARAGRAPH 4:** WHEREAS, IT IS THE RESPONSIBILITY OF STUDENT GOVERNMENT TO SEEK TO IMPROVE CONDITIONS ON CAMPUS THAT ARE DISAGREEABLE AND INFORM THE STUDENT BODY OF ANY PROGRESS OR LACK THEREOF, AND
- PARAGRAPH 5:** WHEREAS, IT WILL BE THE RESPONSIBILITY OF THE STUDENT SENATE HOUSING COMMITTEE TO COMPILE AND ORGANIZE A REPORT BASED ON THE EVALUATIONS SUBMITTED AND PRESENT THEIR FINDINGS TO FACILITY SERVICES AND THE UNIVERSITY, AND
- PARAGRAPH 6:** WHEREAS, SUCH A COMMITTEE WOULD WORK DIRECTLY WITH FACILITY SERVICES AND THE UNIVERSITY AND, WHEN NECESSARY, COULD PUBLICIZE ANY INABILITY OF CURRENT SERVICES ON CAMPUS TO MAINTAIN AND IMPROVE LIGHTING AND SAFETY ON CAMPUS.
- PARAGRAPH 7:** THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE HEREBY RECOMMENDS THAT INDIVIDUALS FROM EACH COLLEGE COUNCIL, FEC, AND ALL RESIDENTIAL HALLS COMPLETE AND RETURN A MONTHLY EVALUATION ON THE STATE OF LIGHTING AND SAFETY ON AREAS ASSIGNED TO THEM BY THE STUDENT SENATE HOUSING COMMITTEE. THE REPORTS SHOULD BE DONE ON THE FIRST WEEK OF EVERY MONTH AND TURNED INTO THE STUDENT GOVERNMENT OFFICE FOR REVIEW.
