**A RESOLUTION**

**TO RECOMMEND THAT THE LSU BOARD OF SUPERVISORS CONSIDER  
EXPANDING THE NUMBER OF SEATS ALLOCATED TO STUDENTS IN TIGER  
STADIUM.**

**PARAGRAPH 1:** WHEREAS, JOE DEAN, THE LSU ATHLETIC DIRECTOR, HAS STATED THAT THE NUMBER OF TICKETS ALLOCATED TO STUDENTS IS SET BY THE BOARD OF SUPERVISORS, AND

**PARAGRAPH 2:** WHEREAS, CHANCELLOR JENKINS HAS STATED THAT HE IS "IN FAVOR OF MEETING STUDENT DEMAND FOR TICKETS," AND

**PARAGRAPH 3:** WHEREAS, AN ADDITION TO TIGER STADIUM WILL CREATE AN ADDITIONAL 11,500 SEATS, OF WHICH THE STUDENTS WILL RECEIVE ONLY ONE THOUSAND, AND

**PARAGRAPH 4:** WHEREAS, A LARGE NUMBER OF ADDITIONAL SEATS, FORMERLY HELD BY SEASON TICKET HOLDERS, HAVE BECOME AVAILABLE DUE TO RECENT CHANGES IN TICKET POLICY, AND

**PARAGRAPH 5:** WHEREAS, THESE TWO EVENTS WILL CREATE ONE OF THE LARGEST SURPLUSES OF NON-DEDICATED SEATS IN THE STADIUM'S HISTORY, AND

**PARAGRAPH 6:** WHEREAS, THIS AVAILABILITY HAS COME AT A TIME WHEN STUDENT DEMAND FOR SEASON TICKETS IS ANTICIPATED TO EXCEED THE NUMBER OF TICKETS CURRENTLY ALLOCATED TO THE STUDENT BODY.

**PARAGRAPH 7:** THEREFORE, BE IT RESOLVED THAT THE LSU A&M STUDENT SENATE RECOMMEND THAT THE LSU BOARD OF SUPERVISORS TAKE ADVANTAGE OF THE CURRENT AND FUTURE TICKET SURPLUS TO MEET THE STUDENT DEMAND FOR TICKETS.
