9 PARAGRAPH 1: WHEREAS, THE CURRENT RULES OF ORDER CONCERNING
10 COMMITTEES ARE INACCURATE AND OUTDATED; AND

12 PARAGRAPH 2: WHEREAS, THERE EXIST AREAS AND EX-OFFICIO MEMBERS THAT
13 ARE NO LONGER APPLICABLE TO THE STANDING COMMITTEES AS
14 LISTED; AND

16 PARAGRAPH 3: WHEREAS, THESE AMENDMENTS AIM TO REMEDY THE ERRORS
17 AND OBSOLETE POSITIONS CURRENTLY LISTED IN THE RULES OF
18 ORDER; AND

49 (D) The Speaker of the Student Senate shall serve as an ex-officio, non-voting member of all

53 Rule 6.4. Referral to Standing Committees

54 All legislation, except Bills of Impeachment, shall be referred by the Speaker according to the
55 topic matter as hereinafter set forth to one (1) appropriate standing committee listed herein;
56 provided, however that at the time of referral any member may object to the referral and may
57 move to assign the legislation to another committee named in the motion.
58

59 (A) ACADEMIC AFFAIRS: To this committee shall be referred, in accordance with the rules, all
60 legislation

61 and other matters relating to the following subjects:

- 62 a. Academic, educational affairs and programs.
- 63 b. University faculty, including any matters before the Faculty Senate.
- 64 c. All matters relating to textbooks.
- 65 d. Computer-based testing.
- 66 e. Financial aid.
- 67 f. Academic issues relating to the Code of Student Conduct.
- 68 g. Academic calendar.
- 69 h. All in-class issues, including the electronic use policy.
- 70 i. Matters relating to LSU Libraries, with the exception of the building hours or maintenance.
- 71 j. All matters related to service-learning courses.
- 72 k. All matters related to enrollment.
- 73 l. Other matters as ordered by the Student Senate.

75 (B) CAMPUS AFFAIRS AND SUSTAINABILITY: To this committee shall be referred all legislation
76 and

77 other matters relating to the following subjects:

- 78 a. All matters relating to **the infrastructure and amenities of** on-campus housing, including the
79 Residence Halls and Greek housing. **This excludes matters directly relating to the student**
80 **activities of LSU Residential Life.**
- 81 b. The construction, demolition, or modification of structures or areas on campus.
- 82 c. ~~Facility Planning.~~ **Planning, Design, and Construction**
- 83 d. Facility Services.
- 84 e. The University Master Plan.
- 85 f. Issues pertaining to sustainability and conservation.
- 86 g. All issues relating to campus parking, traffic, and transportation.
- 87 h. All matters relating to campus safety.
- 88 i. All matters relating to campus lighting.
- 89 j. Other matters as ordered by the Student Senate.

91 (C) BUDGET AND ~~APPROPRIATIONS~~ **APPROPRIATIONS**: To this committee shall be referred, in
92 accordance with the rules, all legislation and other matters relating to the following subjects:

- 93 a. The Student Government Budget Bill.
- 94 b. Fiscal affairs of the Student Government, including expenditures by the Student Senate.
- 95 c. Budgetary requirements and procedures.
- 96 d. Deposit and investment of Student Government funds.
- 97 e. Except as otherwise stated in these Rules of Order, salaries **and benefits** of Student
98 Government employees.
- 99 f. Revenue raising and revenue measures generally, both ~~of the~~ **pertaining to** Student

100 Government and of the College Councils, including Corporate Sponsorship funds and their
101 allocation.

102 **g. Corporate Sponsorship funds and their allocations.**

103 ~~g.~~ **h. Other matters as ordered by the Student Senate.**

105 (D) RULES: To this committee shall be referred all legislation and other matters relating to the
106 following
107 subjects:

108 a. Services of or for the Student Senate, its members and/or its committees.

109 b. All amendments to any governing document, including the Constitution, Bylaws, Rules of
110 Order, Rules of Court, Election Code, and College Council Constitution.

111 c. Elections and Election Board.

112 d. Appointment of persons to office in the Student Government.

113 e. Other matters as ordered by the Student Senate.

115 (E) STUDENT AUXILIARIES AND SERVICES: To this committee shall be referred all legislation and
116 other matters relating to the following subjects:

117 a. All matters relating to athletics, including issues related, **but not limited to**, student ticketing,
118 Tiger Stadium, priority points, and intramural sports.

119 b. All matters relating to **U**niversity technology and Information Technology Services.

120 c. Moodle, myLSU and TigerMail.

121 d. LSU Dining, Union Vendors and **all issues concerning contracted vendors**
122 **(Chartwells/Aramark/Sydesco/etc).**

123 e. All matters relating to ~~Student~~ Auxiliary Services, **Event Management, and the LSU Student**
124 **Union.**

125 **f. All matters relating to Student Services including, but not limited to, the Career Center,**
126 **Bursar's Office, disability services, non-infrastructure issues for on-campus housing services, and**
127 **all other student services.**

128 **f. g. All matters relating to the UREC.**

129 **g. h. All matters relating to TigerCASH/Paw Points.**

130 **j. i. All matters relating to student fees.**

131 **j. All matters relating to LSUPD, Security, and emergency services for students.**

132 **j. k. Other matters as ordered by the Student Senate.**

134 (F) STUDENT LIFE, DIVERSITY AND COMMUNITY OUTREACH: To this committee shall be referred
135 all legislation and other matters relating to the following subjects:

136 a. University disciplinary regulations and all other non-academic matters pertaining to the
137 Student

138 Code of Conduct.

139 b. Cultural affairs and diversity.

140 c. All matters relating to minority, international, and first-generation students.

141 d. All matters relating to retention.

142 e. All matters pertaining to students' constitutional rights and civil liberties.

143 f. Flagship Agenda.

144 g. External affairs of the Student Government.

145 h. Relations between the Student Government and the state government, the city and parish
146 government, other student governments, and national student associations, including, but not
147 limited to the Louisiana Council of Student Body Presidents, the Council of Student
148 Government Associations, the SEC Student Government Conference.

- 149 i. Volunteer and community services.
- 150 j. Student groups and organizations.
- 151 k. Entertainment events and organizations.
- 152 l. All matters pertaining to Free Speech Plaza.
- 153 m. All matters pertaining to First Year Experience.
- 154 n. Other matters as ordered by the Student Senate.

156 **PARAGRAPH 5:** THEREFORE, BE IT ENACTED BY THE LOUISIANA
157 STATE UNIVERSITY STUDENT SENATE THAT THE RULES
158 OF ORDER BE AMENDED TO MORE ACCURATELY REFLECT THE
159 STANDING COMMITTEES AND THEIR RESPONSIBILITIES, AND

161 **PARAGRAPH 6:** BE IT RESOLVED THAT A COPY OF THIS RESOLUTION
162 BE TRANSMITTED TO ANDREW CHENEVERT, CHIEF JUSTICE,
163 CHRISTINA BLACK, SPEAKER OF THE STUDENT SENATE,
164 STEWART LOCKETT, STUDENT BODY PRESIDENT, AHMAD EL-
165 RACHIDI, ATTORNEY GENERAL.

167 **PARAGRAPH 7:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS
168 (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY
169 THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL
170 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
171 APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
