A BILL

TO APPROPRIATE THREE HUNDRED TWENTY DOLLARS (\$320.00) TO THE TURKISH AMERICAN STUDENT ASSOCIATION TO REIMBURSE THE ARTISTS' TRAVEL EXPENSES FOR THE CONCERT TO BE HELD AT THE COLONNADE THEATRE ON FEBRUARY 27, 1998.

PARAGRAPH 1: WHEREAS, THE TURKISH AMERICAN STUDENT ASSOCIATION IS LOOKING TO HOLD A BANQUET TO PROMOTE A BETTER UNDERSTANDING AND DEEPER KNOWLEDGE OF THE TURKISH CULTURE, AND

PARAGRAPH 2: WHEREAS, THIS BANQUET WILL FEATURE LATIF BOLAT, AN INTERNATIONALLY RECOGNIZED SINGER AND COMPOSER OF CLASSICAL, FOLK, AND SUFI TURKISH MUSIC STYLES, AND

PARAGRAPH 3: WHEREAS, INTERACTION BETWEEN INTERNATIONAL AND AMERICAN STUDENTS, FACULTY, AND STAFF WILL IMPROVE THE VALUE OF THE EDUCATIONAL AND SOCIAL EXPERIENCE AT LOUISIANA STATE UNIVERSITY, AND

PARAGRAPH 4: WHEREAS, STUDENT GOVERNMENT SHALL BE LISTED AS A CO-SPONSOR OF THE EVENT ACCORDING TO ARTICLE VI, SECTION 15, SUBSECTIONS A, B, & C OF THE STUDENT GOVERNMENT BYLAWS, AND

PARAGRAPH 5: WHEREAS, THE TURKISH AMERICAN STUDENT ASSOCIATION IS A RECOGNIZED LSU STUDENT ORGANIZATION WITH A GENUINE NEED FOR FUNDING FOR THIS EVENT.

PARAGRAPH 6: THEREFORE THREE HUNDRED TWENTY DOLLARS (\$320.00) IS HEREBY APPROPRIATED FROM THE GENERAL CONTINGENCY TO THE TURKISH AMERICAN STUDENT ASSOCIATION TO REIMBURSE THE ARTISTS' TRAVEL EXPENSES FOR THE CONCERT TO BE HELD AT THE COLONNADE THEATRE.

PARAGRAPH 7: THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A MAJORITY VOTE OF THE LSU A&M STUDENT SENATE. ALL MONIES NOT USED SHALL REVERT BACK TO THE GENERAL CONTINGENCY. THIS BILL SHALL BECOME NULL AND VOID AS OF JUNE 30, 1998.
