## A FINANCE BILL

TO ALLOCATE A MAXIMUM OF EIGHT HUNFRED FORTY-SIX DOLLARS AND SEVENTY-TWO CENTS (\$846.72) FROM THE STUDENT SENATE INITIATIVES ACCOUNT TO FUND SECURITY FOR LATE NIGHT STUDY SPACE FOR THE STUDENT UNION.

**PARAGRAPH 1:** WHEREAS, STUDENT SENATE WILL FUND FOUR OFFICERS FOR THE STUDENT UNION DURING FINALS WEEK FROM DECEMBER 2<sup>ND</sup> TO DECEMBER 5<sup>TH</sup>; AND

**PARAGRAPH 2:** WHEREAS, SECURITY WILL PROVIDE A SAFE ENVIRONMENT FOR STUDENTS UTILIZING THE STUDENT UNION AFTERHOURS; AND

**PARAGRAPH 3:** WHEREAS, SECURITY WILL ALSO PREVENT, DETER, AND MITIGATE TROUBLE THAT MAY HAPPEN TO STUDENTS OR CAUSED BY STUDENTS; AND

**PARAGRAPH 4:** WHEREAS, THE STUDENT UNION WILL BE PROMOTED AND WILL SEE GREATER USE BY STUDENTS; AND

**PARAGRAPH 5:** WHEREAS, THIS FUNDING WILL BE ALLOCATED AS FOLLOWS:

**PARAGRAPH 6:** THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE THAT A MAXIMUM OF EIGHT HUNDRED FORTY-SIX DOLLARS AND SEVENTY-TWO CENTS (\$842.71) FROM THE STUDENT GOVERNMENT INITIATIVES ACCOUNT TO FUND SECURITY FOR LATE NIGHT STUDY IN THE STUDENT UNION; AND

**PARAGRAPH 7:** BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED TO CORTNEY GREAVIS,

STUDENT GOVERNMENT FINANCIAL  
COORDINATOR.

**PARAGRAPH 8:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY TWO-THIRDS ( $2/3$ ) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
