AN EXECUTIVE ORDER

TO ESTABLISH THE “SPECIAL NEEDS PROGRAM TEMPORARY COMMITTEE”

PARAGRAPH 1: WHEREAS, THE COMMITTEE SHALL BE TITLED “SPECIAL NEEDS PROGRAM TEMPORARY COMMITTEE;” AND

PARAGRAPH 2: WHEREAS, THE PRIMARY OBJECTIVE IS TO ESTABLISH A COMMITTEE CONNECTING LSU ADMINISTRATION AND STUDENT GOVERNMENT TO DISCUSS THE NEEDS, CONCERNS, AND POTENTIAL PROGRAMS TO BENEFIT BOTH CURRENT AND POTENTIAL STUDENTS WITH SPECIAL NEEDS.; AND

PARAGRAPH 3: WHEREAS, THE COMMITTEE SHALL HAVE NINETEEN (19) MEMBERS; AND

PARAGRAPH 4: WHEREAS, THE FOLLOWING COMMITTEE MEMBERS SHALL BE LSU ADMINISTRATORS APPOINTED BY NAME:

(A) KELLI WEBBER, ASSISTANT DIRECTOR (ORIENTATION PROGRAMS)

(B) DR. KENTON DENNY, ASSOCIATE PROFESSOR (LSU SCHOOL OF EDUCATION)

(C) PAUL MOONEY, ASSOCIATE PROFESSOR (LSU SCHOOL OF EDUCATION)

(D) RENEE' MYER, DIRECTOR OF ADVOCACY & OUTREACH (COLLEGE OF HSE)

(E) D'ANN MORRIS, SHC EXECUTIVE DIRECTOR

(F) ARLETTE HENDERSON, ASSISTANT TO THE DEAN OF STUDENTS

(G) DR. WANDA HARGRODER, ASSOCIATE PROFESSOR (LSU SCHOOL OF KINESIOLOGY)

(H) BRIDGET ROBICHEAUX, DIRECTOR (CENTER FOR ADVISING AND COUNSELING)

PARAGRAPH 5: WHEREAS, THE FOLLOWING COMMITTEE MEMBERS SHALL BE A REPRESENTATIVE FROM AN LSU ADMINISTRATION'S OFFICE OR DEPARTMENT

(A) REPRESENTATIVE FROM THE OFFICE OF THE PROVOST

(B) REPRESENTATIVE FROM THE DEAN OF STUDENTS

(C) REPRESENTATIVE FROM ENROLLMENT MANAGEMENT

(D) REPRESENTATIVE FROM AUXILIARY SERVICES

- (E) REPRESENTATIVE FROM THE OFFICE OF THE PRESIDENT
- (F) REPRESENTATIVE FROM DISABILITY SERVICES
- (G) REPRESENTATIVE FROM INFORMATION TECHNOLOGY SERVICES
- (H) REPRESENTATIVE FROM THE REGISTRAR'S OFFICE

PARAGRAPH 6: WHEREAS, THE FOLLOWING COMMITTEE MEMBERS SHALL BE STUDENTS APPOINTED BY THE STUDENT BODY PRESIDENT:

- (A) REPRESENTATIVE FROM THE STUDENT BODY PRESIDENT
- (B) PRESIDENT OF HSE AMBASSADORS
- (C) REPRESENTATIVE FROM THE STUDENT BODY EXECUTIVE BRANCH

PARAGRAPH 7: WHEREAS, THE CHAIR OF THE COMMITTEE SHALL BE SENIOR ADVISOR TO THE STUDENT BODY VICE PRESIDENT EMILY JONES; SHOULD THE POSITION BE VACANT, THE PRESIDENT SHALL APPOINT A NEW CHAIR; AND

PARAGRAPH 8: WHEREAS, THE CHAIR SHALL HAVE THE FOLLOWING POWERS AND RESPONSIBILITIES:

- (A) SETTING DATE, TIME, AND DURATION OF THE MEETING
- (B) PRESIDING OVER COMMITTEE MEETINGS
- (C) APPOINTING A VICE CHAIR
- (D) PRIORITIZING CONSIDERATION ON MATTERS PERTAINING TO THE COMMITTEE'S OBJECTIVE
- (E) REQUEST AUTHORIZATION FROM THE PRESIDENT TO INCLUDE THE COMMITTEE IN THE RANKING PROCESS

PARAGRAPH 9: WHEREAS, THE COMMITTEE SHALL MEET IN REGULAR INTERVALS AS SET BY THE STUDENT BODY PRESIDENT; AND

PARAGRAPH 10: WHEREAS; THE COMMITTEE SHALL BE IN EFFECT UNTIL THE END OF THE SPRING 2019 SEMESTER; AND

PARAGRAPH 11: THEREFORE, I, STEWART LOCKETT, BY THE POWER VESTED IN ME BY THE CONSTITUTION OF THE LOUISIANA STATE UNIVERSITY STUDENT GOVERNMENT, DO HEREBY ESTABLISH THE SPECIAL NEEDS PROGRAM TEMPORARY COMMITTEE
