**A BILL**

**TO AMEND THE LSU STUDENT GOVERNMENT BYLAWS REGARDING EXECUTIVE  
STAFF AND SENATORIAL RESPONSIBILITIES**

**BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT  
SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND  
MECHANICAL COLLEGE**

**PARAGRAPH 1:** ARTICLE II, SECTION 8 OF THE STUDENT GOVERNMENT BYLAWS  
IS HEREBY AMENDED TO READ AS FOLLOWS:

**ARTICLE II: Executive Branch Affairs**

§8. Executive Department Reports to Student Senate

Section 8. All Executive Branch Departments shall send a representative to orally report to the Student Senate on their activities at least two (2) times per semester.

**PARAGRAPH 2:** ARTICLE III, SECTION 2 OF THE STUDENT GOVERNMENT  
BYLAWS IS HEREBY AMENDED TO READ AS FOLLOWS:

**ARTICLE III: Legislative Branch Affairs**

§2. Student Senate Committee Reports to the Executive Branch

Section 2. All Chairs of the Student Senate Standing Committees, or their designee, shall meet with their Executive Staff counterparts regarding their activities at least two (2) times per semester.

**PARAGRAPH 3:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS  
(2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY  
THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL  
ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY  
APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
