11 PARAGRAPH 1: WHEREAS, THE CURRENT PLASTIC WASTE PRODUCED ON CAMPUS
12 IS SIGNIFICANT; AND

14 PARAGRAPH 2: WHEREAS, GIVING STUDENTS ALTERNATIVES TO PLASTIC STRAWS
15 IS EFFECTIVE MEASURE IN PROMOTING ENVIRONMENTAL
16 AWARENESS AND SUSTAINABILITY; AND

18 PARAGRAPH 3: WHEREAS, THE UNIVERSITY HAS A RESPONSIBILITY AS A LAND
19 AND SEA GRANT UNIVERSITY TO BE A LEADER IN ENVIRONMENTAL

22 PARAGRAPH 4: WHEREAS THE EXPENDITURE WOULD COVER THE FOLLOWING:

43 ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY
