**A BILL**

**TO AMEND THE LSU STUDENT GOVERNMENT ELECTION CODE ARTICLE II:  
GOVERNANCE OF ELECTIONS TO PROVIDE FOR FURTHER ELECTION OUTREACH**

**BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY STUDENT  
SENATE OF LOUISIANA STATE UNIVERSITY AGRICULTURAL AND  
MECHANICAL COLLEGE THAT**

**PARAGRAPH 1:** ARTICLE II, SECTION 2.B.G OF THE STUDENT GOVERNMENT  
ELECTION CODE IS HEREBY AMENDED TO READ AS FOLLOWS:

- g. To reach out to students to raise awareness on potential candidacy and election
  - i. The Commissioner of Elections shall meet with the College Council Presidents' Commission and the Chair of the Committee on Student Life, Diversity, and Community Outreach prior to election filing and voting to develop and modify plans to promote the election to students in two ways:
    - 1. Utilizing methods of advertising that will reach students more effectively
    - 2. Integrating election filing and voting information into existing college council events when applicable, or allowing each college council to create new outreach events at their discretion

**PARAGRAPH 2:** THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
