A Bill

To Amend the Election Code

*BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY
STUDENT SENATE AS FOLLOWS:*

- 1 §5. Amendments to the Election Code and Effective Dates
- 2
- 3 (A) Section 5.A. As provided by the Student Government Constitution
- 4 (Article VIII, Section 4), the Election Code shall be amended by a two-
- 5 thirds (2/3) vote of the Student Senate present and voting.
- 6 ~~a. Such amendments shall not go into effect until one (1)~~
- 7 ~~semester following passage, not including the Summer~~
- 8 ~~Semester.~~
- 9 a. No amendment that shall be in effect for a specific election
- 10 may be passed prior to the beginning of pre-filing for that
- 11 election (for an election involving candidates) or the submission
- 12 of petitions (for any other election)."

15 THIS BILL SHALL TAKE EFFECT AT THE CALL TO ORDER OF
16 THE FALL 2021 REGULAR SESSION FOLLOWING PASSAGE BY A
17 TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND
18 SIGNATURE BY THE PRESIDENT, LAPSE OF TIME FOR
19 PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT,
20 SUBSEQUENT APPROVAL BY THE SENATE.
