A Bill

An Act making appropriations for the withdrawal of five thousand, three hundred and nine dollars and thirty-one cents (\$5,309.31) from the Student Government Senate Surplus account to be deposited in the Executive Contingency.

Enacted,

1 (\$5,309.31)WHEREAS, the Student Government sponsored the signature event
2 during Welcome Week; and

3 WHEREAS, with the high amount of participation in Welcome Week this year,
4 many students had the opportunity to interact with Student Government for the
5 first time; and

6 WHEREAS, this was a positive outreach opportunity to a large portion of the
7 student body, reaching 1173 students; and

8 WHEREAS, the funds will be allocated as follows:

9 **\$\$5,309.31 to the Executive Contingency Account.**

10 THEREFORE, BE IT ENACTED BY THE LOUISIANA STATE UNIVERSITY
11 SENATE that a maximum of five thousand, three hundred and nine dollars and
12 thirty-one cents (\$5,309.31) from the Student Government Surplus account be
13 allocated to the Executive Contingency account; and

14 BE IT FURTHER RESOLVED THAT A COPY OF THIS BILL BE TRANSMITTED
15 TO; Cortney Greavis, Student Government Program Manager

16 THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A SIMPLE MAJORITY
17 (1/2) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE
SGB 2

18 PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF
19 VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE
20 SENATE, ON THE DATE OF SUCH APPROVAL.
