A Bill

To appropriate a maximum of \$2,000.00 from the Legislative Contingency for food at the Student Government table at Fall Fest

Whereas, Fall Fest is an important event where all students on campus gather for; and,

Whereas, Food will encourage student to visit the Student Government Table; and,

Whereas, It is our duty to our constituents to give back and to listen to them, and Fall Fest provides this opportunity.

Whereas, the budget is currently allocating \$1,500.00 for Jambalaya, and \$500.00 for brownies, both from All Star Catering.

Enacted,

THEREFORE IT BE RESOLVED, THAT THIS BODY ALLOCATES A MAXIMUM OF \$2000.00 FOR FALL FEST CATERING

THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.


