**A Resolution**

*To Urge and Request* Louisiana State University athletics to award letterman jackets to members of the Golden Band from Tiger Land.

WHEREAS, Tiger Band members also participate in many different school sanctioned events outside of athletics

WHEREAS, it stands, athletic trainers, equipment managers and video staff have the ability to obtain a letterman jacket. ; and

WHEREAS, despite these additional athletic affiliates having the ability to receive a letterman jacket, Tiger Band members currently do not have this right; and


WHEREAS, Letterman jackets should be available to Tiger Band members both current and those who exited within the past 4 years.


