**A Resolution**

*To Urge and Request Louisiana State University to create a more efficient  
and effective enforcement of ticket transferring.*

1 WHEREAS, LSU has a Tiger Stadium entry policy contingent on  
2 COVID19 vaccination or testing status.

3

4 WHEREAS, People are able to acquire tickets via a link that is sent  
5 to them from another individual. This creates an opportunity for  
6 unvaccinated and untested people to enter the stadium; and

8 WHEREAS, The transfer and purchase of tickets for guests has  
9 been allowed in previous football seasons, but has not this season in  
10 the interest of limiting opportunities for unvaccinated and untested  
11 people to enter Tiger Stadium; and

13 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE  
14 UNIVERSITY STUDENT SENATE, that Student Government  
15 urges and requests that LSU athletics utilize a method of double  
16 factor authentication such as a SSO (single sign-on) to access the  
17 ticket and presenting state or student identification at the gate.

20 Government urges and requests that LSU athletics allow a method  
21 of ticket transfer that is contingent on both parties meeting the  
22 vaccination or testing requirements (as well as a unique sign-on to  
23 access the link).

25 BE IT FURTHER RESOLVED THAT A COPY OF THIS  
26 RESOLUTION BE SUBMITTED TO LSU Board of Supervisors,  
27 Scott Woodward (Director of LSU Athletics), and Matt Jakoubek  
28 (LSU Athletics Director of Compliance)


