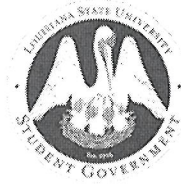

A Concurrent Resolution

To appoint Paris Holman as an Executive delegate for the Program Support Initiative Fund Committee.

1 WHEREAS, Executive Branch member, Paris Holman, is a student leader
2 that represents the students on campus through their position on the
3 Executive Branch; and
4 WHEREAS, the aforementioned name was appointed by the Student Body
5 President; and
6 WHEREAS, it is the Senate's duty to confirm these appointments; and
7 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
8 UNIVERSITY STUDENT SENATE, that Student Government appoint Paris
9 Holman as an executive delegate for the Program Support Initiative Fund
10 committee; and
11 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by a simple
12 majority (one-half plus one) vote of the LSU Student Senate and signature by
13 the Student Body President, upon lapse of time for presidential action, or if
14 vetoed by the President and subsequently approved by the Senate, on the
15 date of such approval.
