- 1 WHEREAS, Executive Branch member, Nicole Spriggs-Moye, is a student
- 2 leader that represents the students on campus through their position on the
- 3 Executive Branch; and
- 4 WHEREAS, the aforementioned name was appointed by the Student Body
- 5 President; and
- 6 WHEREAS, it is the Senate's duty to confirm these appointments; and
- 7 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
- 8 UNIVERSITY STUDENT SENATE, that Student Government appoint

- 11 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by a simple
