A Resolution


*To Urge and Request LSU Administration and LSU Athletic
Administration to refrain from encouraging LSU students in gambling
practices*

- 1 WHEREAS, On January 28, 2022 LSU athletics dispersed an email
- 2 encouraging sports betting, and;

- 7 WHEREAS, Studies have shown gambling can lead to increased debt, and
- 8 lead to other poor life consequences, and;

- 11 THEREFORE BE IT RESOLVED BY THE LOUISIANA STATE
- 12 UNIVERSITY STUDENT SENATE, that the LSU Student Government
- 13 requests LSU Administration and Athletics to refrain from encouraging
- 14 LSU students in gambling practices including the dispersement of emails

- 16 BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE
- 17 SUBMITTED TO LSU Systems President, William Tate, and LSU Athletics
- 18 Director, Scott Woodward

- 20 THIS RESOLUTION SHALL TAKE EFFECT UPON PASSAGE by a simple
- 21 majority (one-half plus one) vote of the LSU Student Senate and signature

22 by the Student Body President, upon lapse of time for presidential action,
23 or if vetoed by the President and subsequently approved by the Senate, on
24 the date of such approval.
