A Bill

The Summer Funding Abilities Bill.

To establish the temporary budget and appropriations committee's ability to appropriate funds, a maximum amount determined by the general Senate body before Senate's Spring semester Sine Die adjournment.

Be it Enacted,

BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE that Title VII Chapter 2 section 105 shall read as follows:

“§ 105. Prohibition on use of funds without budget

With the exception of the appropriation of funds from the Legislative Summer Surplus Account, not exceeding the amount set by the Senate for the Legislative Summer Surplus Account, no funds shall be appropriated or expended in a fiscal year unless and until the Student Government Budget for that fiscal year has been adopted.”

And be it Enacted,

BY THE LOUISIANA STATE UNIVERSITY STUDENT SENATE that Title VII Chapter 4 Section 312 shall be added to the Student Government code and read as follows:


§ 312. Legislative Summer Surplus Account


This account is under the control of the Temporary Budget and Appropriations Committee who shall have full appropriation digression of funds in the account upon a 2/3rds vote of the committee. This account shall

receive funds from the Student Government Surplus Account in amount determined by the Student Government Senate. This account is to be used over the summer and is not to be affected by the change in Fiscal Year that occurs between June 30th and July 1st.

THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY THE PRESIDENT AND SUBSEQUENTLY APPROVED BY THE SENATE, ON THE DATE OF SUCH APPROVAL.
