A Bill to Amend Title VI Chapter 4 Section 306  
of the Student Government Code of the Student  
Government of Louisiana State University

*Enacted,*

3 BY THE LOUISIANA STATE UNIVERSITY STUDENT  
4 SENATE that Title VI Chapter 4 Section 306 shall read as  
5 follows:

6 No individual may recruit or attempt to recruit candidates or  
7 potential candidates for a potential ticket until twelve (12)  
8 class days prior to the candidate registration period.  
9 Violations, in addition to the appropriate penalty under  
10 chapter nine of this title, will cause the recruited  
11 candidate(s) to reduce the ticket's financial limit by \$100  
12 each. Each candidate recruited or attempted to be recruited  
13 before the twelfth-class day before the candidate registration  
14 period, shall constitute a separate violation. Additionally,  
15 each instance of recruitment or attempted recruitment shall  
16 constitute a separate violation.

17 WHEREAS, the LSU Student Senate enacted a hard cap on a  
18 ticket's budget; and

19 WHEREAS, the Senate should adjust its penalty system to  
20 properly account for this change

21 THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A  
22 TWO-THIRDS (2/3) VOTE OF THE LSU STUDENT SENATE  
SGB 8

23 AND SIGNATURE BY THE PRESIDENT, UPON LAPSE OF  
24 TIME FOR PRESIDENTIAL ACTION, OR IF VETOED BY  
25 THE PRESIDENT AND SUBSEQUENTLY APPROVED BY  
26 THE SENATE, ON THE DATE OF SUCH APPROVAL.
