A Bill

To Amend the Student Government Code

Enacted,

1 **Amend:**

2 § 102. Executive officer terms of office

3 All executive officers shall serve terms concurrent with that of the
4 President and Vice President

5 § 103. Dismissal of executive officers

6 All executive officers, except for the Vice President, shall be
7 removed from office by impeachment and may be dismissed from
8 their positions by the President at their discretion.

10 § 102. Executive officer terms of office

11 All executive officers shall serve terms concurrent with that of the
12 President and Vice President

13 § 103. Standard of conduct

14 All Executive Officers shall be held to the highest standard of
15 moral conduct while representing the Student Government.
16 Executive Officers shall at time act with the intention and
17 composure to best represent the interests of their constituents.
18 Any executive officer who fails to abide by the highest standard of
19 moral conduct may be removed from any Student Government
20 meeting, or otherwise sanctioned, by the President


21 § 104 103. Dismissal of executive officers

24 their positions by the President at their discretion.


