*To appropriate a maximum of \$5,500.00 from the
Student Government Initiatives account to fund 1000
Nightcaps® with the Student Government Logo*

- 1 WHEREAS, the Nightcap is a scrunchie connected to a cap
2 that can go on open containers to cover drinks from being
3 tampered with; and

5 WHEREAS, the previous bill to fund Nightcaps was a wild
6 success, with roughly 20 remaining from the S.B.G. 22 from
7 Fall 2021; and

9 WHEREAS, LSU has increasingly promoted awareness and
10 scrutiny on sexual assault cases, and this item can prevent
11 sexual assaults from occurring; and

13 WHEREAS, with this bulk order of 1000 units, the item will
14 cost \$5.50 per unit, totaling \$5,500.00; and

23 used to cover the purchase of 1000 Nightcaps®.




29 THIS BILL SHALL TAKE EFFECT UPON PASSAGE BY A TWO-
